Your F-1 is past due:

Our records indicate that you were an elected or appointed official in 2006. You are required to file an F-1 or F-1A each year to report your personal financial affairs for the previous calendar year. The F-1 was due on April 16, 2007.

Avoid enforcement and a monetary penalty for filing late:

The F-1 report must be received in our office no later than Tuesday, **May 29, 2007**. Faxed or e-mailed F-1 reports are not accepted. If you do not file the F-1 report by May 29, 2007, we will likely begin an enforcement action and schedule a hearing before the Commission that may result in a monetary fine.

You may file the F-1 form:

- by mail or other personal delivery – a blank form is enclosed; or
- electronically at www.pdcc.wa.gov. [Click *Filer Resources, Electronic Filing Option, Electronic Filing links for: (choose candidate type) and Account Logon*. First-time electronic filers click *Personal Financial Affairs Filer* under Account Signup and follow the prompts to establish an account.]

NOTE: Electronic filers must print, sign and deliver the signature authorization to the Public Disclosure Commission. Electronic filings are held in a pending state until the signature authorization is received.

- The PDC does not accept faxed or e-mailed F-1 reports.
- The F-1A cannot be electronically filed.
