The regular meeting of the Public Disclosure Commission was called to order by Commission Chair Amit Ranade at 9:31 a.m. in the Evergreen Plaza Building, Room 206 Olympia, Washington.

Finance Division (MSBE) participated via teleconference and addressed the Commission concerning Maryland's experience with issues of campaign activity on the Internet.

Mr. DeMarinis provided background and shared Maryland's experiences of providing additional disclosures for online campaign activity.

He stated that he reviewed the proposed amendments to Washington's rules; he commended the Commission on its efforts, and suggested the Commission may want to include social media within its definition of mass communications.

Ms. Krier reviewed and summarized the draft possible amended rules and a draft possible new rule in Title 390 WAC addressing campaign activities on the Internet. She explained the scheduling constraints and options for completing the rulemaking process either before June 30 or after the November general election.

Nancy Krier also provided the Commission with copies of additional stakeholder comments submitted during the Commission meeting.

The Commission discussed the drafts, suggested several changes, and asked staff to incorporate changes into draft language for consideration and potential approval at a future meeting in time to hold a public hearing at the May 22, 2013 special meeting, so rules could become effective by June 30.

The Commission went into executive session at 12:02 p.m. to discuss pending and potential litigation with legal counsel.

The Commission returned to public session at 1:00 p.m.

Enforcement

James Fossos, Case No. 12-159, involving alleged violations of RCW 42.17.080 and 42.17.090 by:

- A. Failing to timely report expenditures and in-kind contributions for political advertising, including newspaper advertising, printing and mailing, and signs on Campaign Summary Receipts and Expenditures reports (C-4 reports); and
- B. Failing to timely disclose monetary

Commissioner Turner stated that she is an acquaintance of James Fossos. She stated that she would recuse herself if the Commission requested, but that she believed she would be able to make a fair decision in this matter.

The Commission and the parties did not ask Commissioner Turner to recuse herself from the matter.

Phil Stutzman summarized the allegations and the information presented with the Stipulation as to Facts, Violations and Penalty involving James Fossos. Mr. Fossos was present at the hearing and addressed the

	Staff recommended the Commission accept the stipulation as presented and assess a penalty of \$750, with \$250 suspended on the condition that no further violations occur within the next four years and that the non-suspended portion of the penalty be paid within 30 - days from the date of the final order.

	 accepted anonymous contributions in excess of the \$300 statutory limit and/or failed to properly report the identity of contributors, and
	 failed to make his campaign books of account available for public inspection

	The Commission accept the Staff recommendation to dismiss the remaining allegations on the basis that the investigation revealed Mr. Fossos substantially complied with the applicable laws and regulations within the Commission's jurisdiction.

The Commission grant an exception from electronic filing requirement for the 2012 Miloscia for State Representative Final C-4 report (November 2011 – December 2012).

Ms. Hansen stated that Judge Finkle is requesting a reporting modification to exempt him from reporting his residential address.

She stated that in addition to renewing his prior modification, Judge Finkle has also requested his residential address be redacted from his F-1 filed in 2000. Because there are no other reports filed between 2000 and 2010, the year 2000 is the only retroactive F-1 modification he is requesting. Staff recommended approval of the request for a reporting modification renewal with change as presented.

Mr. Hill is no longer the Director of the Washington State Department of Retirement Systems and is now a mentor of with the Washington State Investment

Moved by Commissioner Sehlin, seconded by Commissioner Turner that: The Commission grant the partial reporting modification as requested, finding that literal application would cause a manifestly unreasonable hardship on the applicant and that a limited modification would not frustrate the purposes of the act.

	Both Commissioner Degginger and Commissioner Turner's Gubernatorial appointments were approved by the Senate Governmental Operations Committee and have been moved to the Rules committee.
	Ms. Doyle reported on the status of agency-request bills and other measures staff is monitoring.
