Notice of Administrative Charges

I. Jurisdiction

 The Public Disclosure Commission (PDC) has jurisdiction over this proceeding pursuant to Chapter 42.17A RCW, the state campaign finance and disclosure laws; Chapter 34.05 RCW, the Administrative Procedure Act; and Title 390 WAC. These charges incorporate the Report of Investigation and all related exhibits by reference.

II. <u>Allegations</u>

2. PDC staff alleges that Paul Schneider, a teacher at University High School in the Central Valley School District No. 356 in Spokane Valley, Washington, violated RCW 42.17A.555 by using the facilities of the Central Valley School District to assist his campaign for School Director in Spokane School District No. 81 in 2015, when he videotaped a political advertisement at his desk in his classroom.

III. <u>Findings</u>

 On May 28, 2015, Paul Schneider filed a Candidate Registration (C-1 report) declaring his candidacy for election to Spokane School District 81 as a School Director. Mr. Schneider was a first-time candidate for public office in 2015. Paul Schneider Notice of Administrative Charges for a Brief Enforcement Hearing PDC Case 15-067 (Ticket 2335) Page 2

- 4. On May 28, 2015, Mr. Schneider videotaped a political advertisement in support of his candidacy in his University High School classroom and at his desk. The videotape was 42 seconds in length, and introduced Mr. Schneider to Spokane area voters as a candidate for Spokane School District School Director in 2015.
- 5. The videotape informed viewers that Mr. Schneider would be communicating with voters via his campaign Facebook page, and through the campaign website which he stated should be up and running soon. Mr. Schneider stated that he would be posting weekly videos on the campaign website and he provided viewers with his campaign website address.
- 6. During the videotape, Mr. Schneider solicited viewers to submit questions to the campaign through the Facebook page and campaign website, and that the weekly videotapes release by the campaign would be posted on the website and provide answers to the questions he had received concerning education issues and his candidacy.

IV. Law

RCW 42.17A.555 states in part: "No elective official nor any employee of his or her office nor any person appointed to or employed by any public office or agency may use or authorize the use of any of the facilities of a public office or agency, directly or indirectly, for the purpose of assisting a campaign for election of any person to any office or for the promotion of or opposition to any ballot proposition. Facilities of a public office or agency include, but are not limited to, use of stationery, postage, machines, and equipment, use of employees of the office or agency during working hours, vehicles, office space, publications of the office or agency, and clientele lists of persons served by the office or agency."

REPORT OF INVESTIGATION

PDC CASE NO: 15-067

Respondent.

I. Background and Allegations

- 1.1 On March 10, 2015, Paul Schneider filed a Candidate Registration (C-1 report) declaring his candidacy for election to Spokane School District 81 as a School Director. **Exhibit #1.** Mr. Schneider is a teacher at University High School in the Central Valley School District No. 356 and he was a first-time candidate for public office.
- 1.2 On May 20, 2015, Patricia A. Kienholz filed a C-1 report declaring her candidacy for election to Spokane School District 81 as a School Director.
- 1.3 On August 6, 2015, Derek Corbin filed a complaint with the Public Disclosure Commission (PDC) alleging that Mr. Schneider used the facilities of the Central Valley School District to assist his campaign for Spokane School District School Director. **Exhibit #2**.
- 1.4 Specifically, Mr. Corbin stated that Mr. Schneider may have violated RCW 42.17A.555 by using Central Valley School District facilities to assist his campaign for Spokane School District School Director, and attached to his complaint three exhibits that included the following:
 - A May 28, 2015, video of Mr. Schneider on sitting at his desk in his Central Valley School District classroom discussing his campaign for School Director.
 - A June 12, 2015, video of Ben Magruder, a University High School student, standing inside of a Central Valley School District classroom campaigning in support of Mr. Schneider.

• A July 9, 2015, video of Kylee Dickinson, a University High School student, on standing inside of a Central Valley School District classroom campaigning in support of Mr. Schneider.

Findings

- 2.1 On August 27, 2015, PDC staff received a telephone call from Mr. Schneider, in which he stated that all students working on his campaign approached him and asked to volunteer to work on his campaign by ringing doorbells or other activities in support of his candidacy. Mr. Schneider stated most of the students that volunteered on his campaign are seniors and that none of them are in any of his classes.
- 2.2 According to Mr. Schneider, a group of University High School students created a Facebook page dedicated to volunteering to work on Mr. Schneider's School Director campaign. Mr. Schneider stated he found out about the Facebook page after the page had been created by the students and put on-line.
- 2.3 On August 27, 2015, PDC Staff received a telephone call from Don Owen, an Advance Placement Government Teacher (AP), at University High School in the Central Valley School District. Mr. Owen stated as part of the AP class, his students are required to participate in some form of political activity, but that the type of activity the student participates in is left up to the student.
- 2.4 Mr. Owen provided a copy of the "Political Project" for his AP Government. Exhibit #3. The "Types of Projects" that the students must participate in included attending a government meeting or formal lecture on a political issue and writing a two-page on what was learned. The projects also included the following:
 - Attend and Score a Debate: The student must attend and score the debate, bring back literature, and have a picture taken proving the student was in attendance.
 - Attend a Political Movement: The student must bring back literature, have a picture taken proving the student was in attendance, and write a two-page paper summarizing the event including the students' opinions on what was observed and how they participated.
 - Help in a Campaign or Political Movement: The student must: (1) participate as a volunteer for a candidate, political party, or organization and engage in activities including doorbelling or leafletting, sign waving, assist in setting up a rally, make telephone calls, etc....; (2) have a picture taken proving the student's was in

attendance; and (3) write a two-page paper summarizing how the students experience and opinions on what was observed and how they participated.

- 2.5 Mr. Owen stated that once the assignment has been completed, the student must write a paper on the political activity they were involved with, and the paper must be at least two pages in length. He stated that many of his AP Government students in the past have worked on political projects and request their assignments for the upcoming school year in advance. He stated that he has had students that have worked on their political projects over the summer months before school started, and added that if a student wants to work on project not listed on the Political Project sheet, the student must get his Mr. Owen's approval first.
- 2.6 On May 28, 2015, Mr. Schneider videotaped a political advertisement in support of his candidacy in his University High School classroom and at his desk. The videotape was 42 seconds in length, and introduced Mr. Schneider to Spokane area voters as a candidate for Spokane School District School Director in 2015. During the videotape, Mr. Schneider:
 - Informed viewers that he would be communicating with voters via his campaign Facebook page, and through the campaign website which should be up and running soon.
 - Indicated that he would be posting weekly videos on the campaign website and he provided viewers his campaign website address.
 - Solicited viewers to submit questions to the campaign through the Facebook page and campaign website.
 - Stated that weekly videotapes would be posted to the campaign website providing answers to questions he had received concerning education issues.
- 2.7 On September 7, 2015, Mr. Schneider submitted an email to PDC staff in response to the allegations listed in the complaint. **Exhibit #4.** Mr. Schneider provided several links to Central Valley School District policies concerning students' rights and responsibilities, and the district's policies on AP programs.
- 2.8 Mr. Schneider stated that the students in the videos are incredibly engaged in school activities, leadership and sports and spend a significant amount of time on school grounds both before and after class times. He stated that the two students made the videos on their own, and that they were not provided special access or authorization to the school facilities and that the students "were not supervised in any specific way."

2.9 Mr. Schneider stated that neither he, Mr. Owen nor any other person authorized, directed or influenced Mr. Magruder or Ms. Dickinson into making the video's to support his candidacy. He posted the video, along with the two other videos made by Mr. Magruder and Ms. Dickinson at University High School, to his campaign website. The video's made by Mr. Magruder and Ms. Dickinson at University High School were part of the normal and regular conduct for students participating in Mr. Owen's AP Government class.

Scope	

3.1 Staff reviewed the following documents:

- A complaint filed against Paul Schneider received on August 6, 2015 from Derek Corbin.
- Copy of the requirements for students to get credit from Mr. Owen's class.
- Video of Mr. Schneider videoed in his classroom at University High School.
- Video of Mr. Magruder videoed in a classroom at University High School.
- Video of Ms. Dickinson videoed in a classroom at University High School.

IV. Law

,

- 4.1 **RCW 42.17A.555** Prohibits the use of public office or agency facilities in campaigns and states the following: "No elective official nor any employee of his or her office nor any person appointed to or employed by any public office or agency may use or authorize the use of any of the facilities of a public office or agency, directly or indirectly, for the purpose of assisting a campaign for election of any person to any office or for the promotion of or opposition to any ballot proposition. Facilities of a public office or agency include, but are not limited to, use of stationery, postage, machines, and equipment, use of employees of the office or agency during working hours, vehicles, office space, publications of the office or agency, and clientele lists of persons served by the office or agency. However, this does not apply to the following activities...:
 - (3) Activities which are part of the normal and regular conduct of the office or agency."

4.2 WAC 390-05-273 Defines normal and regular conduct of a public office or agency, to mean "....conduct which is (1) lawful, i.e., specifically authorized, either expressly or by necessary implication, in an appropriate enactment, and (2) usual, i.e., not effected or authorized in or by some extraordinary means or manner. No local office or agency may authorize a use of public facilities for the purpose of assisting a candidate's campaign or promoting or opposing a ballot proposition, in the absence of a constitutional, charter, or statutory provision separately authorizing such use.

- 1) Candidate for Spokane Public Schools School Board (District 81) Paul Schneider used public school property to film and make 3 separate campaign videos for his school board campaign, violating RCW 42.17A.555 – "use of public facilities to aide a campaign"; and "use of public facilities for political purposes"; and
- 2) On three separate occasions (05/28/15; 06/12/15; 07/09/15) school board candidate Paul Schneider published videos he made while on public school property campaigning for his school board campaign to his public campaign Facebook page "Friends of Paul Schneider"; violating RCW 42.17A.555 "use of public facilities to aide a campaign" and "use of public facilities for political purposes"; and
- 3) In the video posted 07/09/15, University High School student and ASB president Kylee Dickinson can be heard saying "Here at U-High" as she recommends candidate Paul Schneider for Spokane Public Schools school board director. The video was filmed in a University High School classroom. And as of 08/06/15 has been viewed 841 times.

- 4) In the video posted 06/12/15, University High School student Ben Magruder is observed in a public high school classroom, recommending candidate Paul Schneider for Spokane Public Schools school board director. The video was filmed in a classroom and as of 08/06/15 has been viewed 168 times.
- 5) In the video posted 05/28/15, candidate and University High School teacher Paul Schneider is seen sitting in an office at University High School campaigning for election as Spokane Public Schools school board director. As of 08/05/15 the video has been viewed 279 times.

Numbers 1-5 are answered below.

In order to fully answer your questions I must first explain the nature of our high school and the kids who help lead our community. The kids in the videos are incredibly engaged students who are often at school from sun-up to well after dark. They are involved in sports, leadership and other activities that divide their time when they are on campus. I tell you this because to pinpoint "supervision" for either of these engaged students would be nearly impossible. They have at least 10 adult "supervisors" who are engaged with them at any one time. That said, I will try and succinctly answer your questions.

1. No one authorized these students access to the building. They are there doing all kinds of activities and since they are trusted leaders in our community require no "official" authorization to be in the building.

2. Again, no person "authorized" a video production. The students made videos on their own.

3. These particular students were not supervised in any specific way. They are trusted leaders in our building and therefore are not specifically supervised in the comings and goings.

4. This was NOT part of any civics course or assignment

5. Neither the school principal nor the district superintendent were aware in any way of videos being made.
