<b>Explanation of Rule(s)</b>	<p><a href="#">WAC 390-28-100(1)(d)</a>  <b>Personal residence - Real property.</b>          Regarding reporting the information otherwise required by RCW <a href="#">42.17A.710</a> (1)(h) through (k):</p> <p>(i) Under WAC <a href="#">390-24-200</a>, the filer must list the street address of each parcel, the assessor's parcel number, the abbreviated legal description appearing on property tax statements, or the complete legal description. Each property description must be followed by the name of the county in which the property is located.</p> <p>(ii) No modification will be necessary if the filer describes the real property using one of the alternatives in WAC <a href="#">390-24-200</a>, plus the name of the county. Judges, prosecutors, or sheriffs may describe a personal residence in the alternative manner provided under RCW <a href="#">42.17A.710</a>(2), and WAC <a href="#">390-24-200</a> without a modification.</p> <p>(iii) A modification will be required if the filer seeks some other means to describe reportable real property including the personal residence of the filer. The commission may consider and grant such a modification to amend the description of a residential address to the extent necessary to protect the applicant or an immediate family member who has received a threat, has obtained a no contact order, or has presented a similar personal safety concern.</p>

<b>Reason(s) for Modification</b> (as stated by filer)	<ul style="list-style-type: none"><li>• Mark Borden is requesting a partial reporting modification that would exempt him from disclosing his residential address on their Personal Financial Affairs Statements (F-1 report) covering the previous twelve months as a candidate in the 2025 election, due to safety concerns for himself and his family.</li><li>• In his written request, Mr. Borden stated that the last time he “challenged the hospital district” he and his family were victims of property vandalization/defacement and intimidation occurring at his residence.</li></ul>
<b>Other Issues</b>	<ul style="list-style-type: none"><li>• Mr. Borden has agreed to recuse himself if there is a conflict of interest between his duties and their personal interests.</li><li>• PDC staff have informed Mr. Borden of the residential address alternatives set forth in <a href="#">WAC 390-24-200</a>.</li><li>• Mr. Borden’s records would be exempt from public disclosure if the Commission finds in accordance with <a href="#">RCW 42.17A.120</a> and <a href="#">WAC 390-28-080</a> that disclosure of such information would present a personal risk to a reasonable person.</li></ul>
