<b>Explanation of Rule(s)</b>	<p><b>Income and ownership interests.</b> An applicant may be exempted from reporting the information otherwise required by RCW <a href="#">42.17A.710</a> (1)(f) and (g), if:</p> <ul style="list-style-type: none"> <li>(i) Public disclosure would violate any legally recognized confidential relationship that serves a legitimate business interest;</li> <li>(ii) The information does not relate to a business entity which would be subject to the regulatory authority of the office sought or held by the applicant in whole or in part;</li> <li>(iii) Such reporting would present a manifestly unreasonable hardship to the applicant including but not limited to adversely affecting the competitive position of an entity in which the applicant had an interest of ten percent or more as described in RCW <a href="#">42.17A.120</a>; and</li> <li>(iv) The interest in question would present no actual or potential conflict with the performance of the duties of the office sought or held.</li> </ul> <p><b>Personal residence - Real property.</b> Regarding reporting the information otherwise required by RCW <a href="#">42.17A.710</a> (1)(h) through (k):</p> <ul style="list-style-type: none"> <li>(i) Under WAC <a href="#">390-24-200</a>, the filer must list the street address of each parcel, the assessor's parcel number, the abbreviated legal description appearing on property tax statements, or the complete legal description. Each property description must be followed by the name of the county in which the property is located.</li> <li>(ii) No modification will be necessary if the filer describes the real property using one of the alternatives in WAC <a href="#">390-24-200</a>, plus the name of the county. Judges, prosecutors, or sheriffs may describe a personal residence in the alternative manner provided under RCW <a href="#">42.17A.710(2)</a>, and WAC <a href="#">390-24-200</a> without a modification.</li> <li>(iii) A modification will be required if the filer seeks some other means to describe reportable real property including the personal residence of the filer. The commission may consider and grant such a modification to amend</li> </ul>

	<p>the description of a residential address to the extent necessary to protect the applicant or an immediate family member who has received a threat, has obtained a no contact order, or has presented a similar personal safety concern.</p> <p><b>Other.</b> An applicant may be exempted from reporting information otherwise required under RCW <a href="#">42.17A.710</a> which would constitute a manifestly unreasonable hardship in a particular case, when the circumstances presented would not indicate any actual or potential conflict with the proper performance of the duties of the office sought or held. Examples of other common requests will be considered as follows:</p>
