Request for Review/Reconsideration from Tracey Rascon: PDC Case No. 14-091

Agenda Item

Tracey Rascon is seeking a review¹ by the Commission of an initial order entered in a Brief Enforcement Hearing in PDC Case No. 14-091. The review/reconsideration is scheduled for the September 25, 2014, Commission meeting.

Background

- Ms. Rascon is an incumbent School Director for the Cape Flattery School District No. 4 since being appointed to that office in 2006.
- As an incumbent School Director, Ms. Rascon was required to file an F-1 report for calendar year 2013 no later than April 15, 2014.
- A Brief Enforcement Hearing was held on July 8, 2014, at which the Presiding Officer found Ms. Rascon in violation of RCW 42.17A.700 for failing to file an F-1 report for calendar year 2013.
- Ms. Rascon has one prior PDC violation for failing to file an F-1 report for calendar year 2006 in PDC Case No. 07-152.
- Ms. Rascon was assessed a civil penalty of \$300 in accordance with the penalty schedule set forth in WAC 390-37-160, for a filer with one prior violation that failed to file the missing F-1 report by the date of the hearing. The \$300 penalty is payable within 30 days of the date of the order.
- The initial Order was entered July 24, 2014.
- Ms. Rascon filed the missing F-1 report on August 8, 2014.

¹ Based on WAC 390-37-144, since Ms. Rascon's request could not be heard within 20 business days, the initial order becomes a final order, and her request is automatically treated as a request for reconsideration of a final order (rather than a review of an initial order).

Request for Review/Reconsideration

Between August 6 and August 8, 2014, Ms. Rascon exchanged emails with PDC staff concerning the Brief Enforcement hearing, the Order and the \$300 penalty assessed, and her missing F-1 report. Ms. Rascon attached a letter stating she would like to request a reconsideration of the \$300 penalty assessed and that:

- She filed the F-1 report late and apologized for the late filing.
- In February of 2014, she took in a two and one half year old foster child and "...since then I have had difficulties keeping up with everything including my mail."
- She does her banking on-line and her mail "...often goes ignored unfortunately."
- She has been busy with her teenage child, ailing mother, and also dealing with the foster child's mother.

Finally, Ms. Rascon stated in her August 8th email that on July 9, 2014, she attempted to fax her missing F-1 report for 2013, "...which was apparently 1 day after a hearing - I didn't know there was a hearing on the 8th as I was not on top of all my personal affairs at the time. I've also attached the one from 2013."

Ms. Rascon,

Thanks for the email. Your email with the attached letter was forwarded to me.

I reviewed your PDC filing history and could not find a Personal Financial Affairs Statement (F-1 report) filed by you this year for calendar year 2013. The last F-1 report filed by you was received on March 22, 2012 for calendar year 2011. In your letter you referenced filing your F-1 report late, do you recall when you filed it and did you keep a copy? If yes, please email an attached copy of the F-1 report and mail the copy containing an original signature.

In addition, please review your records and see if you have a copy of the F-1 report for calendar year 2012, and submit that report at the same time. Once the F-1 report is received, I will process your request for a review of PDC Case No. 14-091. FYI – the Commission Members are made up of citizens appointed by the Governor and only meet once a month, so you review will likely be heard at the September 2014 Commission meeting.

Findings of Fact, Conclusions of Law, and Order Imposing Fine

A brief enforcement hearing (brief adjudicative proceeding) was held July 8, 2014, in Room 206, Evergreen Plaza Building, 711 Capitol Way, Olympia, Washington to consider whether the Respondent violated RCW 42.17A.700 by failing to file a Personal Financial Affairs Statement (F-1 report) due April 15, 2014, disclosing financial information for calendar year 2013.

The hearing was held in accordance with Chapters 34.05 and 42.17A RCW and Chapter 390-37 WAC. A brief enforcement hearing notice was sent to Tracey Rascon on June 10, 2014. Commission Member Amit Ranade was the Presiding Officer. The Commission staff was represented by Jacob Berkey, Compliance Coordinator. The Respondent did not participate at the hearing, and did not submit any written materials:

Having considered the evidence, the Presiding Officer finds as follows:

FINDINGS OF FACT

- 1. The Respondent was an incumbent School Director for Cape Flattery School District 4 in 2013.
- 2. As a School Director, the Respondent was required to file an F-1 report no later than April 15, 2014.
- 3. The Respondent did not file the missing F-1 report by the date of the hearing.
- 4. The Respondent has one prior violation.

CONCLUSIONS OF LAW

Based on the above facts, as a matter of law, the Presiding Officer concludes as follows:

- 1. This matter was duly and properly convened and all jurisdictional, substantive and procedural requirements have been satisfied.
- 2. The Respondent violated RCW 42.17A.700 by failing to file the F-1 report by April 15, 2014.

ORDER

ON the basis of the foregoing Findings of Fact and Conclusions of Law,

IT IS HEREBY ORDERED that the Respondent is assessed a civil penalty of \$300 in accordance with the penalty schedule set forth in WAC 390-37-160. The penalty is due within 30 days of the date of this Order.

This is an Initial Order of the Public Disclosure Commission.
