Explanation of Rule(s)	<p>Personal residence - Real property. Regarding reporting the information otherwise required by RCW 42.17A.710 (1)(h) through (k):</p> <p>(i) Under WAC 390-24-200, the filer shall list the street address of each parcel, the assessor's parcel number, the abbreviated legal description appearing on property tax statements, or the complete legal description. Each property description shall be followed by the name of the county in which the property is located.</p> <p>(ii) No modification will be necessary if the filer describes the real property using one of the alternatives in WAC 390-24-200, plus the name of the county.</p> <p>(iii) A modification will be required if the filer seeks some other means to describe reportable real property including the personal residence of the filer. The commission may consider a modification, for example, when the filer or his or her immediate family member has received a threat, has a no contact order, or presents a similar personal safety concern.</p> <p>A prospective modification to allow nondisclosure of a residential address may be granted if the applicant or an immediate family member has received a threat, been issued a no contact order or presents a similar personal safety concern.</p>

History (brief narrative)	<p>Judge Allred was appointed to the King County Superior Court in May 2014 and was required to file a Personal Financial Affairs Statement for the previous 12 months as a newly appointed Superior Court Judge.</p> <p>Judge Allred received a Certificate of Election after filing for King County Superior Court in 2014 and was required to file an F-1 for calendar year 2014 and calendar year 2015.</p>
Reason(s) for Modification (as stated by filer)	<ul style="list-style-type: none"> • Judge Allred is requesting a reporting modification that would exempt him from reporting real estate, including street address, parcel number, or legal description, for his residential address on his Personal Financial Affairs Statement covering 2015. • Judge Allred is also requesting a retroactive modification that would exempt him from disclosing real estate, including street address, parcel number, or legal description, for his residence previously listed on the F-1 report filed in May 2014 covering the previous 12 months and the F-1 report covering calendar year 2014. • Judge Allred stated that he has sentenced, and will continue to sentence, numerous defendants for violent crimes, including serious assaults, sex crimes, and threats to kill. • Judge Allred stated that not disclosing his residential address will not hinder the public's ability to ensure whether a conflict of interest exists.
Other Issues	<p>Judge Allred disclosed creditor information, payment terms, security given and mortgage amounts for his personal residence.</p>
