| Reason(s) for Modification (as stated by filer) | <ul style="list-style-type: none"> • Judge Maxa is requesting a reporting modification that would exempt him from disclosing his personal residential address information, including street address, parcel number, or legal description, on his Personal Financial Affairs Statement for the previous 12 months. • Judge Maxa stated that his new duties as a Court of Appeals Judge will expose his family to harm if his residential address is disclosed. • Judge Maxa is requesting a reporting modification that would exempt him from listing the business and governmental customers that made payments of \$10,000 or more of the law firm Gordon Thomas Honeywell LLP during the previous 12 months. • Judge Maxa is a former partner of the law firm Gordon Thomas Honeywell LLP and is no longer involved in the day-to-day operation of the firm. He stated that after he left his position with GTH he no longer had access to the business and governmental customers of the law firm. • Judge Maxa stated that Gordon Thomas Honeywell has annual revenue of 25 to 30 million dollars. He stated that there are over 100 customers who paid \$10,000 or more during to the law firm during the previous 12 months. |
