Explanation of Rule(s)	<p>Applicants whose spouse or registered domestic partner creates a reporting obligation for the applicant. When an applicant is required to report the activities of an entity solely because the applicant's spouse or registered domestic partner held an office, directorship, general partnership or ownership interest in the entity and the applicant does not have direct knowledge of the information that must be reported, the applicant may be allowed to satisfy the disclosure requirements of RCW 42.17A.710 (1)(g)(ii) and WAC 390-24-020 by disclosing reportable customers from whom compensation in excess of the disclosure threshold established under RCW 42.17A.710 (1)(g)(ii) has been received as follows:</p> <p>(A) All payments made by the agency or jurisdiction in which the applicant seeks or holds office to the entity;</p> <p>(B) The business and other governmental customers or clients of the applicant's spouse/domestic partner and of the entity of which the applicant is aware; and</p> <p>(C) Any other business and other governmental customers or clients of the entity whose identities are known to the applicant and whose interests are significantly affected by the agency or jurisdiction in which the applicant seeks or holds office.</p> <p>The commission may apply (e)(i) through (iii) of this subsection when the applicant's spouse/domestic partner is a lawyer, judge, or motor vehicle dealer.</p>

Reason(s) for Modification (as stated by filer)	<ul style="list-style-type: none"> • Ms. Curtis is requesting a reporting modification that would exempt her from disclosing the business and other governmental customers that paid \$12,000, during the previous 12 months, to Spaceflight Industries, Inc., a company engaged in launch and satellite services of which her spouse is President and board member with less than 10% ownership interest. • Ms. Curtis said that Spaceflight Industries, Inc. had \$30 million dollars in revenue, with more than 300 customers and has 108 employees. She stated that almost all of the 300 customers would be subject to disclosure.

	<ul style="list-style-type: none">• Ms. Curtis stated that it would cause a hardship to provide a list of reportable business and other governmental customers of Spaceflight Industries, Inc. due to non-disclosure agreements. In addition, several customers are not identified on the internet.• Ms. Curtis stated that no payments were made by Houghton Community Municipal Corporation to Spaceflight Industries, Inc. during the reporting period.
Other Issues	In lieu of additional written information regarding the applicant's request for an exemption from identifying the reportable business and governmental customers of Spaceflight Industries, Inc., the applicant's spouse, Curtis Blake, will be participating by phone.
