Re: State Representative Jake Fey's Request to Reinstate Loans

AGENDA ITEM

State Representative Jake Fey requests to reinstate loans made by him to his 2005 and 2010 campaigns that were reported as having been forgiven December 12, 2010.

BACKGROUND

Repayment of loans made to a campaign is authorized by RCW 42.17A.445.¹ Only loans which are recorded in a written loan agreement executed at the time of the loan and properly reported may be repaid. RCW 42.17A.465² and WAC 390-16-226. Repayment of personal loans made by a candidate is limited to the dollar amount set out in RCW 42.17A.445(3). That dollar amount is adjusted by the Commission in even-numbered years.

In 2005, Jake Fey was a successful candidate for Tacoma City Council. The Committee to Elect Jake Fey reported receiving primary and general election loans from Fey totaling \$8,000, which was within the repayment limit allowed in 2005. The loans remained unpaid at the end of the 2005 campaign. Attachment A

In 2009, Fey was reelected to the Tacoma City Council. The first C-4 report filed by the 2009 Committee to Elect Jake Fey showed that loans totaling \$8,000 were carried forward from the 2005 campaign. Attachment B No additional loans were made to the campaign, and the last C-4 filed by the 2009 campaign reported two unpaid loans totaling \$8,000. Attachment C

In 2010, Fey registered a campaign for state representative and carried the loans totaling \$8,000 forward once again. Attachment D Fey made additional primary and general election personal loans to the 2010 campaign totaling \$9,200, which was within the repayment limit allowed in 2010. On December 31, 2010, Fey's committee filed a final C-4 report for the 2010 campaign showing four unpaid loans totaling \$17,200. Attachment E Craig Kerr was the treasurer for the 2005, 2009 and 2010 campaigns.

On September 26, 2011, Fey registered a 2012 campaign for state representative and listed Craig Kerr as the treasurer. Attachment F An amended registration was filed in November 2011

naming Jason Bennett as the campaign treasurer performing only ministerial functions.

Attachment G Jason Bennett is the owner of Argo Strategies, which provides campaign support, including campaign finance reporting services to candidates and political committees. On December 13, 2011, Fey's committee filed an amended final report for the 2010 campaign reporting that the four loans totaling \$17,200 had been forgiven on December 12, 2010. Attachment H Jason Bennett is the treasurer named on the amended C-4 report.

In December 2013, Representative Fey contacted PDC staff to confirm the outstanding loan amount owed to him. When told that the loans had been forgiven according to the amended final report for the 2010 campaign, Representative Fey stated that he had not authorized the loans to be forgiven.

In the attached March 5, 2014 letter, Jason Bennett explains that a former Argo Strategies staff member misunderstood Representative Fey's intentions when he contributed personal funds after the 2010 election to retire the campaign's debts.³ The letter further explains that the former staff member believed that Representative Fey wished to retire all debt at that time. COMMISSION ACTION

It is common for a candidate or political committee to file an amendment upon discovering that a report contains a mistake. Amendments are typically filed to fix incorrect amounts or dates. These amendments are routinely filed without permission from the Commission or staff.

Even though Representative Fey's campaign contractor has notified the staff that reporting the loans as forgiven was a mistake, staff believes an advisory decision from the Commission is appropriate. Staff is not aware of any prior instances of a loan being reinstated after it was forgiven or that such a request has ever been made. In the event the Commission allows the reinstatement, staff believes it is important to memorialize the circumstances under which the request was granted in case future requests to reinstate forgiven loans are received.

The Commission may also wish to consider adopting an interpretive statement to provide guidance regarding the reinstatement of loans and common loan questions, such as whether a candidate's personal funds contribution may be repaid by the campaign or from surplus funds when it was not reported as a loan at the time the contribution was made.

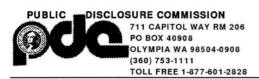

Thank you for the correspondence and advice today regarding Rep. Jake Fey's loan from his 2007 and 2010 races.

Both sets of loans were accidentally "forgiven" at the end of the 2010 election season. A previous employee of Argo Strategies had misunderstood Rep. Fey's intentions when he donated additional personal funds to cover remaining campaign debts during that period. It was believed then Rep. Fey was closing out the campaigns debts with that personal donation to cover expenses and eventually close the account. However, we know now that was not the case.

Because our former staff person is no longer at Argo Strategies, it took some time to try and recover correspondences and records from that period.

We understand that loans do not have a date by which they must be forgiven or paid back. Further, we understand that these loans can roll over legally as a continuous debt/obligations from election to election until they are paid off (subject to the contribution limit). Please understand this was an inadvertent error while trying to close out the books for the 2010 cycle.

We respectfully ask that we are allowed to re-instant the loans as a debt and obligation. Rep. Fey intends to fundraise to pay himself back all of his legal loan amounts in full. We are happy to file the amended reports to fix this inadvertent error.
