The firm is located in Kennewick, Washington. He stated that compiling a list of reportable business customers would be burdensome and time consuming on the firm's staff. • Mr. Forgette disclosed the names of his clients, the firm's government clients, and a partial listing of the firm's business clients, which are already publicly available. • Mr. Forgette stated that the firm had no business customers whose interests would be significantly affected by actions of the Board of Regents of Washington State University.
Other Issues	Mr. Forgette stated that no payments were made by Washington State University (WSU) to Rettig Osborne Forgette, LLP in 2012.

Dear Mr. Beatty:

For the last nine years I have been granted a modification with regard to the filing of my Personal Financial Affairs Statements (PDC Forms F-1 and F-1A).

Please consider this letter as my written application and request for a continuation of the reporting "modification" or "waiver" which was granted to me in prior years by the Public Disclosure Commission under PDC Order Nos. 2675, 2698, 2749, 2846, 2878, 2932, 2987, 3061 and 3090.

In summary, I am respectfully seeking the same modifications that were granted by the PDC under its previous orders. In support thereof, I represent that none of the material facts relevant to my last application have changed.

There are, however, two new items I am reporting on now: First, I am reporting on my voluntary service on the Executive Committee and the Board of the Association of Washington Business. Secondly, I am reporting on my paid position as the corporate secretary for Vista Engineering Technologies, Inc. F-1 Supplement pages are included as to both of these entities.

I am submitting my 2013 PDC Form F-1A with this letter for consideration along with this request.

I understand that a hearing will now be scheduled to consider my requested renewal of the PDC's previous orders in this regard. I am waiving my right to attend the hearing in person. See also attached waiver form which I have signed.
