#### I. Jurisdiction

 The Public Disclosure Commission (PDC) has jurisdiction over this proceeding pursuant to RCW 42.17A, the campaign disclosure and contribution law; RCW 34.05, the Administrative Procedure Act; and WAC 390. These charges incorporate the Report of Investigation and all related exhibits by reference.

#### II. Allegations

- 2. PDC staff alleges that Gary Jensen, a candidate for Port of Bellingham Commissioner in 2015, violated RCW 42.17A.235 and .240 by failing to timely report contributions on paper-filed C-3 reports totaling \$11,405, filed 8-36 days late; and on electronically filed C-3 reports totaling \$6,244, filed 1-15 days late; and by failing to timely report expenditures on paper-filed C-4 reports totaling \$4,135, filed 1-40 days late; and on electronically filed C-4 reports totaling \$4,102, filed 60-105 days late.
- 3. In addition, staff alleges the Mr. Jensen violated RCW 42.17A.245 by failing to report contributions and expenditures by the electronic alternative provided by the commission in a timely manner after the campaign expected to expend \$5,000 or more during the campaign, which occurred on or around August 31, 2015.

4. The Jensen campaign's expenditures exceeded \$5,000 on September 18, 2015. However, the campaign reported aggregate contributions of \$7,440 on its Post-Primary C-4 covering the period July 28 thru August 31, 2015, which created a presumption that the campaign projected spending \$5,000 or more during the campaign. Thus the campaign was required to file its Post-Primary C-4 electronically on September 10, 2015. The campaign e-filed its Post-Primary C-4 on October 27, 2015, 47 days late.

#### III. Facts

- 5. In 2015, Gary Jensen was a candidate for Port of Bellingham Commissioner. His treasurer was Suzanne Nevan. Mr. Jensen was defeated in the November 3, 2015 general election. The campaign raised and spent approximately \$19,618.
- 6. The Jensen campaign initially filed eight C-3 reports on paper. The paper-filed reports disclosed \$12,405 in contributions received from June 16, 2015 through October 6, 2015. The reports were filed between June 19 and October 20, 2015. One C-3 disclosed a \$1,000 contribution from the candidate and was timely filed. Seven C-3 reports disclosed \$11,405 in contributions and were filed 8-36 days late.
- 7. On October 27, 2015, the campaign filed C-3 reports electronically totaling \$15,899. Many of the contributions filed electronically were previously reported on paper-filed C-3 reports. Six electronically filed C-3 reports totaling \$6,244 had not been previously filed on paper-filed reports. They were filed from 1 to 15 days late.
- 8. Initially, the Jensen campaign filed its C-4 reports on paper, filing 11 reports covering May 1, 2015 through October 10, 2015, from June 1 through October 20. These reports disclosed aggregate contributions of \$12,405 and aggregate expenditures of \$5,443. Of these expenditures, \$1,308 was filed timely; \$371 was filed one day late; \$596 was filed six days late; \$1,103 was filed seven days late; and \$2,065 was filed 40 days late.
- 9. On October 27, 2015, seven days before the general election, the campaign electronically filed five C-4 reports covering activity for the period June 1 thru October 26, 2015. The first four reports covered the period June 1 thru October 12, which had previously been covered by paper-filed reports. The fifth report was the 7-Day Pre-General C-4, and it timely disclosed \$10,074 in expenditures. On February 8, 2016, the campaign filed its Post-General C-4 report 60 days late, disclosing \$3,781 in expenditure activity.

- 10. The e-filed 21-Day Pre-Primary C-4 (June 1 thru July 13), disclosed \$692 in expenditures. Of this amount, \$371 was previously reported one day late on a paper-filed C-4 and \$321 was filed 105 days late.
- 11. RCW 42.17A.245 requires candidates that spend \$5,000 or more in the preceding year or expect to spend \$5,000 or more in the current year to file their C-3 and C-4 reports electronically.
- 12. WAC 390-19-030 provides quarterly expenditure benchmarks to determine when a candidate "expects to spend" \$5,000 or more, and therefore has an electronic filing requirement under RCW 42.17A.245. The rules states, in part, that electronic filing is required if a filer's expenditures meet or exceed \$3,750 on or before September 30 of the current calendar year, or if a filer otherwise projects that \$5,000 or more will be spent during the current calendar year.
- 13. The Jensen campaign's expenditures exceeded \$5,000 on September 18, 2015. However, the campaign reported aggregate contributions of \$7,440 on its Post-Primary C-4 covering the period July 28 thru August 31, 2015. Because contributions exceeded \$5,000, it is presumed that the campaign projected that it would spend \$5,000 or more, triggering the effiling requirement. Thus the campaign was required to file its Post-Primary C-4 electronically on September 10, 2015, to re-file past C-3 and C-4 reports electronically, and file all remaining reports electronically.
- 14. The Respondent has no prior violations. However, Mr. Jensen filed reports electronically during campaigns for Mayor of Ferndale in 2007 and 2011.

#### IV. Law

RCW 42.17A.225, 235 and 240 require candidates and continuing political committees to file timely, accurate reports of contributions and expenditures. Under the full reporting option, until five months before the general election, C-4 reports are required monthly when contributions or expenditures exceed \$200 since the last report. C-4 reports are also required 21 and 7 days before each election in which the committee makes expenditures, and in the month following the election. Contributions are reported weekly during this same time period, and must be disclosed on Monday for contributions deposited the previous seven days.

RCW 42.17A.245 states that each candidate or political committee that expended five thousand dollars or more in the preceding year or expects to expend five thousand dollars or more in the current year shall file all contribution reports and expenditure reports required by this chapter by the electronic alternative provided by the commission under RCW 42.17A.055.

WAC 390-19-030 provides for quarterly expenditure benchmarks to use in determining when a candidate "expects to spend" \$5,000 or more, and therefore has an electronic filing requirement under RCW 42.17A.245. The rules states, in part, that electronic filing is required if a filer's expenditures meet or exceed \$3,750 on or before September 30 of the current calendar year; or a filer otherwise projects that \$5,000 or more will be spent during the current calendar year.

#### I. Background

- 1.1 In 2007, Gary Jensen was a candidate for Mayor of Ferndale. He selected the Full Reporting option and filed his reports electronically. During his 2007 campaign, Mr. Jensen raised and spent \$4,012, and was elected Mayor of Ferndale on November 6, 2007. In 2011, Mr. Jensen ran for re-election, and again selected the Full Reporting option, filing his reports electronically. He raised and spent \$4,675, and was re-elected Mayor of Ferndale on November 8, 2011.
- 1.2 In 2015, Mr. Jensen was a candidate for Port of Bellingham Commissioner. He initially filed his Candidate Registration (PDC Form C-1) on January 12, 2015, selecting the Full Reporting option, and noting on the registration that he did not yet have a treasurer. On July 15, 2015, Mr. Jensen amended his C-1, stating that his treasurer was Suzanne Nevan. (Exhibit 1)
- 1.3 Mr. Jensen was defeated in the November 3, 2015 general election.

# II. Allegations

2.1 On October 22, 2015, Abe Jacobson filed a complaint alleging that Gary Jensen, candidate for Port of Bellingham Commissioner, had filed no PDC reports since August 31, 2015. Mr. Jacobson also alleged that Mr. Jensen's campaign had raised and spent more than \$5,000, but had not filed its reports by the required electronic method. Mr. Jacobson complained that given the amount of "dark money" flowing into the county, the public needed to be able to monitor financing details on a timely basis in order to inform their vote. (Exhibit 2)

2.2 On October 25, 2015, Doug Karlberg filed a complaint alleging that Mr. Jensen reported contributions on October 22, 2015 that were due to be reported by October 12, 2015. Mr. Karlberg noted that there was an ongoing controversy over a proposed coal terminal that played a major role in the decision of voters about which Commissioner candidates to support. He alleged that Mr. Jensen did not timely reveal that he was taking coal money, and that this fact was not known until after ballots had been received by voters. He also alleged that Mr. Jensen had been filing C-3 and C-4 reports on paper rather than by the required electronic method. He alleged that Mr. Jensen had been advised of this requirement by private parties, but had ignored the advice. Mr. Karlberg did not provide any evidence of this allegation. He noted that when Mr. Jensen ran for Mayor of Ferndale in 2007 and 2011 he filed electronically. (Exhibit 3)

#### III. Findings

It appears that the 2015 Gary Jensen campaign for Port of Bellingham Commissioner raised and spent approximately \$19,618. The last C-4 report filed by the Jensen campaign covered the month of December 2015, and shows aggregate contributions of \$16,924 and aggregate expenditures of \$19,618, leaving a Cash-on-Hand balance of (\$2,694). Because expenditures cannot exceed contributions, it appears that the campaign raised and spent \$19,618, but was unable to correctly report contributions. Suzanne Nevan, Campaign Treasurer, was asked to correct the reports and file a final C-4 report, but has not done so. Ms. Nevan stated that she has tried to correct the reports, but apparently lacks the expertise to properly correct all reports. The campaign was required to file C-3 and C-4 reports in accordance with a schedule published by PDC staff. (Exhibit 4)

#### C-3 Reports of Contributions (Exhibits 5-10)

- 3.2 The Jensen campaign initially filed eight C-3 reports on paper. The paper-filed reports disclosed \$12,405 in contributions received from June 16, 2015 through October 6, 2015. The reports were filed between June 19 and October 20, 2015. One C-3 disclosed a \$1,000 contribution from the candidate and was timely filed. Seven C-3 reports disclosed \$11,405 in contributions and were filed between 8 and 36 days late.
- 3.3 Following is a chart showing contributions received and reported on C-3 reports, both paper-filed and e-filed, by the 2015 Gary Jensen campaign. On October 27, 2015, the campaign filed C-3 reports electronically totaling \$15,899. Many of the contributions filed electronically were previously reported on paper-filed C-3 reports. Six electronically filed C-3 reports totaling \$6,244 had not been previously filed on paper-filed reports. They were filed from 1 to 15 days late and are shown in bold in the chart below.

#### C-4 Reports Showing Expenditures (Exhibits 5-10)

- 3.4 Initially, the Jensen campaign filed its C-4 reports on paper, filing 11 reports covering May 1, 2015 through October 10, 2015, from June 1 through October 20. These reports disclosed aggregate contributions of \$12,405 and aggregate expenditures of \$5,443.
- 3.5 Following is a chart showing contribution and expenditure activity reported on the 11 paper-filed C-4 reports, and on the e-filed C-4 reports filed on October 27, 2015 and February 8, 2016. For the 11 paper-filed C-4 reports that disclosed expenditures totaling \$5,443, \$1,308 was filed timely; \$371 was filed one day late; \$596 was filed six days late; \$1,103 was filed seven days late; and \$2,065 was filed 40 days late.
- 3.6 On October 27, 2015, seven days before the general election, the campaign electronically filed five C-4 reports covering activity for the period June 1 thru October 26, 2015. The first four reports covered the period June 1 thru October 12, which had previously been covered by paper-filed reports. The fifth report was the 7-Day Pre-General C-4, and it timely disclosed \$10,074 in expenditures.
- 3.7 On February 8, 2016, the campaign filed its Post-General C-4 report 60 days late, disclosing \$3,781 in expenditure activity, and a report for December 2015, showing no activity.

3.8 The e-filed 21-Day Pre-Primary C-4 (June 1 thru July 13), disclosed \$692 in expenditures. Of this amount, \$371 was previously reported on a paper-filed C-4 and \$321 was filed 105 days late.

#### Requirement to File C-3 & C-4 Reports Electronically

- 3.9 RCW 42.17A.245 requires candidates that spend \$5,000 or more in the preceding year or expect to spend \$5,000 or more in the current year to file their C-3 and C-4 reports electronically.
- 3.10 WAC 390-19-030 provides quarterly expenditure benchmarks to determining when a candidate "expects to spend" \$5,000 or more, and therefore has an electronic filing requirement under RCW 42.17A.245. The rules states, in part, that electronic filing is required if a filer's expenditures meet or exceed \$3,750 on or before September 30 of the current calendar year, or if a filer otherwise projects that \$5,000 or more will be spent during the current calendar year.
- 3.11 The Jensen campaign's expenditures exceeded \$5,000 on September 18, 2015. However, the campaign reported aggregate contributions of \$7,440 on its Post-Primary C-4 covering the period July 28 thru August 31, 2015. Because contributions exceeded \$5,000, it is presumed that the campaign projected that it would spend \$5,000 or more, triggering the e-filing requirement. Thus the campaign was required to file its Post-Primary C-4 electronically on September 10, 2015, to re-file past C-3 and C-4 reports electronically, and file all remaining reports electronically.

#### Response from Suzanne Nevan, Campaign Treasurer (Exhibit 11)

- 3.12 On November 6, 2015, Suzanne Nevan submitted a letter and stated that she served as a volunteer treasurer for the Gary Jensen campaign. She acknowledged filing handwritten reports throughout most of the campaign and lagging behind in filing during the last month and a half of the campaign. She stated that she sent in all the required paperwork to file electronically, but when she did not receive anything back, continued to file paper reports by U.S. mail.
- 3.13 Ms. Nevan acknowledged that she lacked experience, but insisted that her late reporting and lack of electronic filing was not an attempt to hide anything. She stated that learning to use the PDC's filing software was difficult, and admitted that she did not do well with it. Ms. Nevan said that during the week before the general election, she received several calls asking about donors. She said she provided the callers with the requested information and offered to show them the campaign books, but no one took her up on her offer.
- 3.14 Ms. Nevan said most of the donors were local people with the exception of several unions based out of Seattle and Everett. She said the campaign received no money from out of state.
- 3.15 Ms. Nevan said her father has been suffering from congestive heart failure, and over the summer months they nearly lost him several times, which she described as a distracting influence in her efforts to serve as Mr. Jensen's campaign treasurer. Ms. Nevan said she also had to leave the county for a short time during the campaign to attend her son's wedding. Ms. Nevan said she truly attempted to do her best in her role as treasurer, and accepts full responsibility for coming up short.

#### Responses from Gary Jensen, Candidate (Exhibits 12 & 13)

- 3.16 On November 9, 2016, Mr. Jensen responded to the complaints. He acknowledged that the complaints appear to be valid. He said Suzanne Nevan, his Campaign Treasurer, is a dedicated public servant who works full time for the Ferndale Fook Bank. He noted that Ms. Nevan attempted to contact the PDC with filing questions, and in addition, suffered through some family medical problems and was out of the country for a short time while serving as Treasurer. He noted that while not an excuse for the mistakes that were made, it was difficult for his Treasurer to file by the electronic filing method. He stated that he lost the election by 44% to 56% and was outspent when he spent \$16,000 and his opponent spent \$42,000. He said he would abide by any enforcement decision made by the Commission.
- 3.17 On January 19, 2016, when PDC staff informed Mr. Jensen that staff would be conducting a formal investigation, he submitted an additional response to the complaints. Mr. Jensen stated that the two complainants were key contributors and volunteers to his opponent's campaign, and said both did everything possible to affect his campaign in a negative light, including attempting to taint his reputation with allegations that "outside coal money" had funded his campaign, an allegation that Mr. Jensen denied.

3.18 Mr. Jensen stated that the negative campaign was life changing for him, and while he intends to continue serving the public in some way, he will never run for any political office in the future. Mr. Jensen said he realizes and acknowledges that mistakes were made in his campaign. He said it was difficult to run and manage a campaign while also working the two jobs of running a small company and serving as the Mayor of Ferndale. However, he acknowledged that the campaign's mistakes are his responsibility, and said he will live with the consequences and pay whatever fine is assessed without appeal.

#### IV. Scope

- 4.1 PDC staff reviewed the following:
  - Complaints filed by Abe Jacobson and Doug Karlberg
  - C-1, C-3 and C-4 reports filed by the Gary Jensen campaign.
  - Written responses to complaints received from Gary Jensen and from the campaign treasurer, Suzanne Nevan.
  - Staff spoke with Suzanne Nevan, Campaign Treasurer.

# V. **Laws and Rules**

Under the full reporting option, until five months before the general election, C-4 reports are required monthly when contributions or expenditures exceed \$200 since the last report. C-4 reports are also required 21 and 7 days before each election in which the committee makes expenditures, and in the month following the election. Contributions are reported weekly during this same time period, and must be disclosed on Monday for contributions deposited the previous seven days.
- 5.2 RCW 42.17A.245 states that each candidate or political committee that expended five thousand dollars or more in the preceding year or expects to expend five thousand dollars or more in the current year shall file all contribution reports and expenditure reports required by this chapter by the electronic alternative provided by the commission under RCW 42.17A.055.
- 5.3 WAC 390-19-030 provides for quarterly expenditure benchmarks to use in determining when a candidate "expects to spend" \$5,000 or more, and therefore has an electronic filing requirement under RCW 42.17A.245. The rules states, in part, that electronic filing is required if a filer's expenditures meet or exceed \$3,750 on or before September 30 of the current calendar year; or a filer otherwise projects that \$5,000 or more will be spent during the current calendar year.

Mr. Gary S. Jensen, candidate for Port of Bellingham commissioner, has filed no PDC reporting since 08-31-2015. Yet he has raised and spent more than \$5000. so far. None of his reporting since 08-31-2015. For example, Mr. Jensen has not filed a c4 for the period ending October 12. Nor has he done electronic filing as is required for > \$5000.

In effect, the campaign of Gary S. Jensen is keeping the public entirely in the dark as to his finances. Given the amount of dark money currently flowing into the County I find this really troubling. The public is supposed to be able to monitor financing details on a timely basis in order to inform their vote.

Gary Jensen, the current Mayor of the City of Ferndale filed his public disclosure of campaign contributors on Oct. 22. They were due Oct. 12. Mr. Jensen is running for a Port of Bellingham Commissioners position. This offense is egregious, as this filing is right before the ballots are mailed and denied many voters this information prior to voting.

An ongoing controversy over the proposed coal terminal plays a major role in voters decisions of whom to support. Mr. Jensen played coy and did not reveal that he was taking coal money until after many ballots had been filed in and returned.

Additionally, Mr. Jensen has been filing handwritten forms, and should be filing electronically. Mr. Jensen was informed of this by private parties, and ignored their advice. Also when Mr. Jensen ran for the Mayor of Ferndale, he managed to file electronically.

This last minute filing by coal industry supporters is becoming a pattern, and in this case may throw an election, as the only coal industry monies reported were after the ballots had been in the voters hands for a week.

If Mr. Jensen had revealed his association with the coal industry prior to ballots being received by voters, or the coal issue was not a major and controversial issue, this may not have made a difference in this election, but unfortunately this is not the case.

I am the volunteer treasurer for Gary Jensen's campaign. I filed handwritten reports to the PDC throughout the campaign and did lag behind the last month and a half. At the offset, I did request a filer ID and sent in all the paperwork for electronic signatures. I did not receive anything back from the PDC and so rather than wait, I continued to file the reports via US Mail.

My lack of experience was glaring in this endeavor and that is what it was...not an attempt to hide anything. The ORCA system does have a steep learning curve and I'm afraid that I did not do well with it. I do have a notebook and all backup paperwork is neat and orderly and sequential. The week before the election, I did receive several phone calls from folks asking about donors and I provided information and offered to meet folks to show them the "books." No one took me up on that offer and Mr. Jacobsen was not one of the callers.

As you can see from the uploaded information, all donors were local folks with the exception of several unions based out of Seattle or Everett. No money came to our campaign from out of state.

I think of myself as a capable person but my dad has been suffering from congestive heart failure and over the summer months we almost lost him several times. I have been distracted and truly attempted to do my best in this role for the campaign. I take full responsibility for coming up short.

Recently I joined the League of Women Voters and I have suggested that perhaps we could partner with the PDC to do some training on ORCA. Being new to the elections process, I feel like I could have used some coaching. Is that something you all would entertain?

In addition she suffered through some family medical problems and was out of the country for a bit.

That is not an excuse, we realize mistakes were made. For some people with limited technical, computer skills, the electronic filing can be complicated but again probably not a valid excuse. As of this time, all of our reports have been filed and if Mr. Jacobsen would desire to inspect all of our files, he only has to ask. If he desires a personal contact and apology, that will be accomplished. He can call me personally if he wishes.

Again we realize this is not a valid excuse for missing an important deadline.

The election is now over and our campaign was on the losing end, 44% to 56%. We were out funded at 16 thousand plus to 42 thousand plus.
