	<ul> <li>ommercial soft tree fruit grown in Washington State or packed as Washington State soft tree fruit.</li> <li>Mr. Gutzwiler stated that as a board member, his role is to give direction to managers on how soft fruit should be marketed domestically and internationally. He said he is not involved with the day-to-day operations of the Commission. He stated that the amount of work for their accounting staff of four to trace all payments received over the \$10,000 threshold from every grower would cause an undue hardship.</li> <li>National Cherry Growers &amp; Industries Foundation</li> <li>Mr. Gutzwiler stated that the National Cherry Growers &amp; Industries Foundation is a national foundation headquartered in Hood River, Oregon that promotes the sale of processed cherries in the US, by charging</li> </ul>
