Other Issues	<p>Mr. Chamberlain disclosed that he completed a public records search with Skamania County. The result of this search was that none of the companies has done business with the county in the previous 12 months. Mr. Chamberlain also stated that given the nature of these companies' business, it is highly unlikely they would do business with the County.</p> <p>Mr. Chamberlain stated a search of each of the company's websites did not result in any customer information except between WKO and High Cascade Forest LLC.</p> <p>Mr. Chamberlain stated that should a matter arise involving any of the companies or any of their customers of which he might become aware and the office in which he seeks election (Skamania County Auditor), he will consult the County's attorney for advice on preceeding.</p>
