Each property description shall be followed by the name of the county in which the property is located.</li> <li>(ii) No modification will be necessary if the filer describes the real property using one of the alternatives in WAC <u>390-24-200</u>, plus the name of the county.</li> <li>(iii) A modification will be required if the filer seeks some other means to describe reportable real property including the personal residence of the filer. The commission may consider a modification, for example, when the filer or his or her immediate family member has received a threat, has a no contact order, or presents a similar personal safety concern.</li> <li>A prospective modification to allow nondisclosure of a residential address may be granted if the applicant or an immediate family member has received a threat, been issued a no contact order or presents a similar personal safety concern.</li> </ul>
