<b>Explanation of Rule(s)</b>	<p><b>Personal residence - Real property.</b> Regarding reporting the information otherwise required by RCW 42.17A.710 (1)(h) through (k):</p> <p>i. Under WAC 390-24-200, the filer shall list the street address of each parcel, the assessor's parcel number, the abbreviated legal description appearing on property tax statements, or the complete legal description. Each property description shall be followed by the name of the county in which the property is located.</p> <p>ii. No modification will be necessary if the filer describes the real property using one of the alternatives in WAC 390-24-200, plus the name of the county.</p> <p>iii. A modification will be required if the filer seeks some other means to describe reportable real property including the personal residence of the filer. The commission may consider a modification, for example, when the filer or his or her immediate family member has received a threat, has a no contact order, or presents a similar personal safety concern.</p> <p>A prospective modification to allow nondisclosure of a residential address may be granted if the applicant or an immediate family member has received a threat, been issued a no contact order or presents a similar personal safety concern.</p>

<b>Reason(s) for Modification (as stated by filer)</b>	<ul style="list-style-type: none"> <li>• Mrs. Madsen is requesting a reporting modification to exclude their residential address from the F-1 covering 2019, filed on March 10, 2020.</li> <li>• Mrs. Madsen states that she is requesting the exclusion of home address for protection of her family from possible harm.</li> <li>• Mrs. Madsen states that she is seeking to be elected as a trial court judge, which would be qualified under categorical exemption.</li> <li>• Mrs. Madsen states that professionally her legal practice has a high-risk focus for high-risk family situations, as she represents children and youth in foster care as well as parents arguing over raising children and custody issues.</li> <li>• Mrs. Madsen states that often there are credible accusations of violence included in cases she works, such as convictions for domestic violence and stalking as well as a case that involved a parent escalating and shooting family pets and then taking children across state lines.</li> <li>• Mrs. Madsen states that she volunteers to mentor offenders and would not want these offenders to know where she lives for safety reasons.</li> <li>• Mrs. Madsen states that her mother, Barbara Madsen, WA State Supreme Court Justice, has received death threats and that these threats have included herself and other family members, such as having had a suspicious person found underneath her mother's state issued vehicle that caused state patrol to have to investigate and ensure no devices were planted.</li> </ul>
