Explanation of Rule(s)	<p>Personal residence - Real property. Regarding reporting the information otherwise required by RCW 42.17A.710 (1)(h) through (k):</p> <p>(i) Under WAC 390-24-200, the filer shall list the street address of each parcel, the assessor's parcel number, the abbreviated legal description appearing on property tax statements, or the complete legal description. Each property description shall be followed by the name of the county in which the property is located.</p> <p>(ii) No modification will be necessary if the filer describes the real property using one of the alternatives in WAC 390-24-200, plus the name of the county.</p> <p>(iii) A modification will be required if the filer seeks some other means to describe reportable real property including the personal residence of the filer. The commission may consider a modification, for example, when the filer or his or her immediate family member has received a threat, has a no contact order, or presents a similar personal safety concern.</p> <p>A prospective modification to allow nondisclosure of a residential address may be granted if the applicant or an immediate family member has received a threat, been issued a no contact order or presents a similar personal safety concern.</p>

Reason(s) for Modification (as stated by filer)	<ul style="list-style-type: none"> Judge Napoli O'Toole is requesting renewal of a reporting modification that would exempt her from disclosing her personal residential address information, including street address, parcel number, or legal description, on her Personal Financial Affairs Statement covering calendar year 2018.

	<ul style="list-style-type: none">• Judge Napoli O'Toole stated that she presides over criminal cases and domestic violence and anti-harassment protection order cases. She stated that these cases involve parties who are disgruntled at the outcome or sentencing in the case and that she has received threatening letters from past defendants.• Judge Napoli O'Toole stated that her husband is a Senior Deputy Prosecutor in King County who prosecutes high profile murder cases involving the most dangerous offenders. He has also received threats in the past requiring police protection.• Judge Napoli O'Toole stated that disclosing her home address poses a risk for her personal safety as well as that of her husband and children.
Other Issues	<p>Judge Napoli O'Toole disclosed creditor information, payment terms, security given and mortgage amounts for her personal residence.</p> <p>Judge Napoli O'Toole has agreed to recuse herself if a matter came before her involving a conflict of interest between her personal residence and King County District Court.</p> <p>Judge Napoli O'Toole has reviewed and included information from her previous reporting modification requests to indicate that there are no changes to the facts related to her request.</p>
