Reason(s) for Modification (as stated by filer)	 Ms. Rolfs is requesting a new reporting modification that would exempt her from disclosing the business customers that paid \$12,000 or more during calendar year 2020 to Pacific Engineering & Design, PLLC, of which her spouse is a partner and has a 26% ownership interest.
	 Pacific Engineering & Design, PLLC is an engineering firm located in Wenatchee, with 21 employees, 100 customers, and annual sales of more than three million. Ms. Rolfs stated that there are 28 reportable business customers of Pacific Engineering & Design, PLLC.

	 Ms. Rolfs stated that she is not involved in the day-to-day operations of the firm, does not have access to the list of customers, and that identifying them would violate non-disclosure agreements with Pacific Engineering & Design, PLLC's customers.
Other Issues	Ms. Rolfs has agreed to recuse herself if a matter came before her involving a conflict of interest between Pacific Engineering & Design, PLLC and Pinnacles Prep Charter School.
	Ms. Rolfs has disclosed all reportable governmental customers of Pacific Engineering and confirmed that Pacific Engineering & Design, PLLC received no payments from Pinnacles Prep.
