On April 26, 2012, the application of Steven Rosen, Post Office Box 34987, Seattle, Washington 98124, for a modification of the reporting requirements of RCW 42.17.241¹ was brought before the Public Disclosure Commission.

Consideration of the request was made pursuant to RCW 42.17A.120² and chapter 390-28 WAC by the Commission. The proceedings were held in Room 206, Evergreen Plaza Building, 711 Capitol Way, Olympia, Washington, 98504. The applicant, Steven Rosen, by Modification Application, requested a renewal of the reporting modification that would exempt him from disclosing his personal residential address information, including street address, parcel number, or legal description, on his Personal Financial Affairs Statement for 2011.

The Commission was provided with a certification from Judge Rosen waiving his personal appearance at the hearing and stating that the facts contained in the request are true and accurate.

FINDINGS OF FACT

Based upon the Modification Application, the Commission makes the following Findings of Fact:

- 1. Judge Rosen has previously been granted the requested reporting modification, the most recent being Order No. 2984.
- 2. Judge Rosen is an elected Municipal Court Judge for the City of Seattle. His elected term expires in 2014.
- 3. Judge Rosen stated that as a Seattle Municipal Court Judge, he presides over arraignments, bail setting, trials, sentencings, etc.
- 4. Judge Rosen stated that he has been threatened by defendants, including one who threatened to shoot him with a shotgun. A police report was filed for this incident.
- 5. Judge Rosen disclosed the assessed value and creditor information for real estate property he owns in Washington State.

CONCLUSIONS OF LAW

Having made these Findings of Fact, the Commission makes the following Conclusions of Law:

- 1. Literal compliance with all the provisions of the reporting requirements of RCW 42.17.241³ would work a manifestly unreasonable hardship on the applicant.
- 2. Limited suspension or modification of the reporting requirements as specified in the Order would not frustrate the purposes of the Act in this particular case.

ORDER

Having made these Findings of Fact and Conclusions of Law, the Commission issues the following Order:

For the Statement of Personal Financial Affairs required to be filed with the Public Disclosure Commission between January 1 and April 16, 2012:

- 1. The applicant may satisfy the reporting requirements of RCW 42.17.241(1)(j)³ with respect to his personal residence by providing the assessed value, creditor information, payment terms, security given and mortgage amount codes.
- 2. In all other matters required to be reported, the applicant shall comply in full with the reporting requirements of RCW 42.17/42.17A.
