I. Jurisdiction

1. The Public Disclosure Commission (PDC) has jurisdiction over this proceeding pursuant to Chapter 42.17A RCW, the state campaign finance and disclosure laws; Chapter 34.05 RCW, the Administrative Procedure Act; and Title 390 WAC. These charges incorporate the Report of Investigation and all related exhibits by reference.

II. Allegations

2. PDC staff alleges that Tom Mielke, Clark County commissioner, violated RCW 42.17A.555 by: (1) using his Clark County email address to oppose Proposition 1, the 2014 Clark County Home Rule Charter ballot measure; and (2) using his Clark County email address to assist the 2014 Clark County Commissioner campaign of Jeanne Stewart.

III. Facts

3. The November 4, 2014 general election ballot in Clark County included Proposition 1, a Home Rule Charter ballot measure that if approved would replace the existing system of three County Commissioners. In addition, Craig

Pridemore and Jeanne Stewart were on the general election ballot running for the position of County Commissioner in District 3.

4. Voters approved the Home Rule Charter by a 53.35% to 46.65% margin, with 63,731 Yes votes and 55,727 No votes.
5. Jeanne Stewart defeated Craig Pridemore in the race for County Commissioner, District 3, by 0.21%, receiving 60,131 votes to Mr. Pridemore's 59,226 votes.

Alleged use of county email to oppose Proposition 1, the Clark County Home Rule Charter ballot measure, by telling Darlene Johnson to not let the Woodland Chamber of Commerce take a position on the ballot measure

6. On October 23, 2014, Commissioner Mielke used his Clark County email address to respond to Darlene Johnson of the Woodland Chamber of Commerce, and tell her, "... *Please don't let the chamber take a position on this, it will put them in a bad light.*"
7. Commissioner Mielke was responding to an email he received from Ms. Johnson at his Clark County email address that she had received from John "JJ" Burk, Executive Director of the Woodland Chamber of Commerce. The email chain included an email from Kelly Love, CEO/President of the Greater Vancouver Chamber of Commerce, explaining why the Greater Vancouver Chamber of Commerce and the Camas-Washougal Chamber of Commerce officially supported Proposition 1. Ms. Johnson forwarded the email chain to Commissioner Mielke at his Clark County email address and at his personal email address with the comment, "*Thought you might be interested in what is being emailed to Chamber on the Charter issue. Dar*"
8. Commissioner Mielke responded using his Clark County email address by saying, "*Wow! Hi Dar, I can't believe how hard they are working to do private*

presentations and so on. I'm not sure who the 60% might be, but the Charter is a disaster. Please don't let the chamber take a position on this, it will put them in a bad light. Tom"

Alleged use of county email to assist the 2014 Clark County Commissioner campaign of Jeanne Stewart by subscribing to and accepting an email that supported Ms. Stewart and opposed her opponent, Craig Pridemore

9. On October 23, 2014, Commissioner Mielke used his Clark County email address to respond to an email from Larry Patella's "Local Mailing List" with a subject of "What Others Are Saying" by stating, "Wow! Just wow! Hard to believe all this went right down party lines ... Enough about working well with others. Tom"
10. The email started out by stating, "Good Morning, Please read and then vote for Jeanne Stewart. Below is information provided by reliable sources and the Fish Wrapper spotlighting the highlights of Pridemore's political career. As you can see, Pridemore repeatedly ignored the voice of the people and has voted for, or spoke in favor of: multiple taxes & hikes ... bridge tolls... elimination of the 2/3 majority in Olympia..., etc."
11. The email concluded by stating that the facts were obtained by scanning the archives of The Columbian newspaper from 1996 to the Summer of 2014 concerning Craig Pridemore's political history which resulted in two files attached to the emails titled "Pridemore Report."
12. Commissioner Mielke subscribed to and accepted the "Local Mailing List" email at his Clark County email address of tom.mielke@clark.wa.gov. Even though the email included instructions for unsubscribing to the emails created by Mr. Larry Patella, Commissioner Mielke maintained his subscription to receive Mr.

Patella's emails at his Clark County email address, which in this case, was an email supporting Jeanne Stewart and opposing Craig Pridemore, candidates for Clark County Commissioner.

IV. Law

RCW 42.17A.555 states: "No elective official nor any employee of his or her office nor any person appointed to or employed by any public office or agency may use or authorize the use of any of the facilities of a public office or agency, directly or indirectly, for the purpose of assisting a campaign for election of any person to any office or for the promotion of or opposition to any ballot proposition. Facilities of a public office or agency include, but are not limited to, use of stationery, postage, machines, and equipment, use of employees of the office or agency during working hours, vehicles, office space, publications of the office or agency, and clientele lists of persons served by the office or agency. However, this does not apply to the following activities: ... (3) Activities which are part of the normal and regular conduct of the office or agency.

WAC 390-05-273 defines the "normal and regular conduct" of a public office or agency as "conduct which is (1) lawful, i.e., specifically authorized, either expressly or by necessary implication, in an appropriate enactment, and (2) usual, i.e., not effected or authorized in or by some extraordinary means or manner."

I.
BACKGROUND

- 1.1 The November 4, 2014 general election ballot in Clark County included Proposition 1, a Home Rule Charter ballot measure that if approved would replace the existing system of three County Commissioners. In addition, Craig Pridemore and Jeanne Stewart were on the general election ballot running for the position of County Commissioner in District 3.
- 1.2 Voters approved the Home Rule Charter by a 53.35% to 46.65% margin, with 63,731 Yes votes and 55,727 No votes.
- 1.3 Jeanne Stewart defeated Craig Pridemore in the race for County Commissioner, District 3, by 0.21%, receiving 60,131 votes to Mr. Pridemore's 59,226 votes.
- 1.4 On February 17, 2015, the Public Disclosure Commission (PDC) received a complaint from Jacqueline Lane alleging that Clark County Commissioner Tom Mielke may have violated RCW 42.17A.555 by using his Clark County email address to oppose the 2014 Clark County Home Rule Charter ballot proposition, and to assist a 2014 Clark County Commissioner candidate by

supporting her campaign and opposing her opponent's campaign. The allegations were reviewed by PDC staff and a formal investigation was conducted.

II. ALLEGATIONS IN COMPLAINT

- 2.1 Jacqueline Lane alleged that Clark County Commissioner Tom Mielke may have violated RCW 42.17A.555 (Use of public office or agency facilities in campaigns) on several occasions during 2014 by using his Clark County email address to campaign against Proposition 1 and to support Jeanne Stewart for Clark County Commissioner. The Complaint was received February 17, 2015, and included three exhibits in support of the alleged violations. **(Exhibit 1)**
- 2.2 The first exhibit to the complaint was an email dated July 29, 2014, titled: "Resolution to Defeat the Charter.docx" which the complainant alleged Commissioner Mielke forwarded to the 18th Legislative District Republicans.
- 2.3 The second exhibit to the complaint was an email dated October 23, 2014, in which Commissioner Mielke urged a Woodland Chamber of Commerce member to not let the Woodland Chamber of Commerce take a position on the Home Rule Charter ballot proposition.
- 2.4 The third exhibit to the complaint was an email dated October 23, 2014, in which Commissioner Mielke expressed his opposition to County Commissioner Candidate Craig Pridemore and his support for candidate Jeanne Stewart, to a group called "Local Mailing List."

III. FINDINGS

Alleged use of county email to oppose Proposition 1, the Clark County Home Rule Charter ballot measure, by forwarding a document titled "Resolution to Defeat the Charter.docx." to the 18th Legislative District Republicans

- 3.1 On July 29, 2014, Commissioner Mielke received an email at his Clark County email address from John Anderson with a subject line "A Resolution To Defeat The Freeholders' Charter." Mr. Anderson sent the email to the Clark County Republicans, and copied Commissioner Mielke at his Clark County email address. Also on July 29, 2014, Commissioner Mielke forwarded the email to his personal email address which is district18rep@msn.com. **(Exhibit 2)**

- 3.2 On March 15, 2015, Commissioner Mielke responded to the complaint by stating that he has used the email address district18rep@msn.com as his personal email address since he was a State Legislator representing the 18th Legislative District. Commissioner Mielke stated *"The first item of complaint was that I forwarded political papers to the Republican Party. As a personal rule, anything that comes to my County office that appears to be personal, I forward it onto my home computer which the PDC may verify my using it over several campaigns in the past. That email address is: district18rep@msn.com. Used and kept from my days as a State Legislator representing the District18."* **(Exhibit 3)**
- 3.3 Although it appears the complainant believed the email address district18rep@msn.com is the address for the 18th Legislative District Republicans, it is Commissioner Mielke's personal email address. A review of Commissioner Mielke's last three Candidate registrations (PDC form C-1) for 2008, 2012, and 2015 confirms that his personal email address is district18rep@msn.com. **(Exhibit 4)**
- 3.4 No evidence was provided or found that Commissioner Mielke used his Clark County email address to forward material opposing the Home Rule Charter ballot measure to the 18th Legislative District Republicans.

Alleged use of county email to campaign against Proposition 1, the Clark County Home Rule Charter ballot measure, by telling Darlene Johnson to not let the Woodland Chamber of Commerce take a position on the ballot measure

- 3.5 The Greater Vancouver Chamber of Commerce and the Camas-Washougal Chamber of Commerce officially supported the Home Rule Charter ballot proposition. Commissioner Mielke opposed Proposition 1.
- 3.6 On October 23, 2014, Commissioner Mielke used his Clark County email address to respond to Darlene Johnson of the Woodland Chamber of Commerce, and tell her, *"... Please don't let the chamber take a position on this, it will put them in a bad light."* **(Exhibit 5)**
- 3.7 Commissioner Mielke was responding to an email he received from Ms. Johnson at his Clark County email address that she had received from John "JJ" Burk, Executive Director of the Woodland Chamber of Commerce. The email chain included an email from Kelly Love, CEO/President of the Greater Vancouver Chamber of Commerce, explaining why the Greater Vancouver Chamber of Commerce and the Camas-Washougal Chamber of Commerce officially supported Proposition 1. Ms. Johnson forwarded the email chain to Commissioner Mielke at his Clark County email address and

at his personal email address with the comment, *"Thought you might be interested in what is being emailed to Chamber on the Charter issue. Dar"*

- 3.8 Commissioner Mielke responded using his Clark County email address by saying, *"Wow! Hi Dar, I can't believe how hard they are working to do private presentations and so on. I'm not sure who the 60% might be, but the Charter is a disaster. Please don't let the chamber take a position on this, it will put them in a bad light. Tom"*
- 3.9 Commissioner Mielke also defended emails received from personal friends at his county email address by stating, *"...looking at the dates and times of the email exchange between John JJ Burke on Oct 22nd at 2:07pm. Then Darlene Johnson, a personal friend sent to me, Tom Mielke on Oct 22nd at 2:21pm what appears to be from John JJ Burke. My recommendation back to my friend was to remain neutral. Not for nor against. Also note that the Woodland Chamber is in Cowlitz County and it appears the message being passed around was from Kelly Love of the Vancouver Chamber in Clark County. If it makes a difference, Cowlitz County didn't have a vote in the Charter."*

Alleged use of county email to campaign for Jeanne Stewart, a candidate for Clark County Commissioner, and to oppose her opponent, Craig Pridemore, by subscribing to and accepting an email that supported Ms. Stewart, received from a group called "Local Mailing List"

- 3.10 On October 23, 2014, Commissioner Mielke used his Clark County email address to respond to an email from Larry Patella's *"Local Mailing List"* with a subject of *"What Others Are Saying"* by stating, *"Wow! Just wow! Hard to believe all this went right down party lines ... Enough about working well with others. Tom"* (**Exhibit 6**)
- 3.11 The email started out by stating, *"Good Morning, Please read and then vote for Jeanne Stewart. Below is information provided by reliable sources and the Fish Wrapper spotlighting the highlights of Pridemore's political career. As you can see, Pridemore repeatedly ignored the voice of the people and has voted for, or spoke in favor of: multiple taxes & hikes ... bridge tolls... elimination of the 2/3 majority in Olympia..., etc."*
- 3.12 The email concluded by stating that the facts were obtained by scanning the archives of The Columbian newspaper from 1996 to the Summer of 2014 concerning Craig Pridemore's political history which resulted in two files attached to the emails titled "Pridemore Report."
- 3.13 As noted earlier, Commissioner Mielke stated when he receives emails at his Clark County email address that appear to be personal, he forwards them to his home email address. However, Commissioner Mielke

subscribed to and accepted the "Local Mailing List" email at his Clark County email address.

- 3.14 The email included instructions for unsubscribing to the Republican Party emails created Mr. Larry Patella, by including the following closing statement at the bottom of the October 23, 2014 email: "The following information is a reminder of your current mailing list subscription: You are subscribed to the following list: Local Mailing List, using the following email: tom.mielke@clark.wa.gov. If you would like to unsubscribe, please contact the list owner at: Impatella@comcast.net.
- 3.15 On March 15, 2015, Commissioner Mielke responded to this allegation by stating: "*...part of the complaint dealt with an email from Larry Patella (Local Mailing List) on Oct.23rd at 8:01 am on a number of issues. Me, Tom Mielke's response was the fact the voting on the issues I saw were down party lines. ? Obviously, I responded and never sent him any political papers.*" (Exhibit 3)

IV. **SCOPE**

- 4.1 Staff reviewed the following documents:
- A complaint against Tom Mielke, Clark County Commissioner/Counselor received on February 15, 2015 from Jacqueline Lane with exhibits.
 - March 13, 2015 email from Tom Mielke.
 - March 15, 2015 emailed response to complaint from Tom Mielke.

V. **LAW**

RCW 42.17A.555 states, in part, "No elective official nor any employee of his or her office nor any person appointed to or employed by any public office or agency may use or authorize the use of any of the facilities of a public office or agency, directly or indirectly, for the purpose of assisting a campaign for election of any person to any office or for the promotion of or opposition to any ballot proposition. Facilities of a public office or agency include, but are not limited to, use of stationery, postage, machines, and equipment, use of employees of the office or agency during working hours, vehicles, office space, publications of the office or agency, and clientele lists of persons served by the office or agency."

WAC 390-05-273 defines the "normal and regular conduct" of a public office or agency as "conduct which is (1) lawful, i.e., specifically authorized, either expressly or by necessary implication, in an appropriate enactment, and (2) usual, i.e., not effected or authorized in or by some extraordinary means or manner."

Resolution To Defeat The Freeholders' Charter

The Republican Party believes that transparency is essential to good governance.

Whereas, this Freeholders' Charter limits the quantity and quality of information that is easily and directly obtained by the people and their elected representatives. Three full-time Commissioners are replaced by five "Councilors" who only meet twice a month. These Councilors will be totally dependent on staff for critical information and department oversight. Only the at-large Council Chair is allowed to speak publicly on County business. (See Section 2.2); and,

The Republican Party is deeply committed to the principle that government must be accountable and responsive to the citizens it serves.

Whereas, the Freeholders' Charter removes power from the voter and their Commissioners, and transfers the power to an unelected Manager, staff and the at-large Council Chair. The Charter diminishes representative democracy in Clark County and once lost cannot be reclaimed. (See Section 2:6); and,

The Republican Party believes in the importance of checks and balances on power.

Whereas, the Initiative/Referendum offered in the Charter as a check on power is a toothless tiger which offers no real check on power. The Freeholders' Charter specifies that due to Constitutional limits, Charter prohibitions and court decisions, the initiative/referendum offered in the Charter does not allow citizens to use a petition to address taxes, budgets, fees, projects, policy issues or even the Charter itself. Then Darlene Johnson, a personal friend sent to me, Tom Mielke on Oct 22nd at 2:21pm what appears to be from John JJ Burke. My recommendation back to my friend was to remain neutral. Not for nor against. Also note that the Woodland Chamber is in Cowlitz County and it appears the message being passed around was from Kelly Love of the Vancouver Chamber in Clark County. If it makes a difference, Cowlitz County didn't have a vote in the Charter.

- By reducing the work load it allows more people who already have jobs the opportunity to serve as Councilor (like city councils).
