Reason(s) for Modification (as stated by filer)	 Mr. Wisenteiner is requesting a reporting modification that would exempt him from disclosing the business customers that paid \$12,000 or more during calendar year 2015 to Horn Distributing Co., Inc. (Horn Distributing), a privately held, family owned real estate holding company located in New Mexico. Mr. Wisensteiner stated that Horn Distributing has 4 to 7 customers, 2 employees and an annual revenue of \$500,000. Mr. Wisenteiner is a minority shareholder and 16.33% owner of Horn Distributing. Mr. Wisenteiner stated that he is not involved in the day to day operations of Horn Distributing. Mr. Wisenteiner stated that 5 of the clients of Horn Distributing would be reportable.

	 Mr. Wisenteiner believes that disclosing these customers would put the Horn Distributing at a competitive disadvantage and put it at risk for competitive intelligence gathering. In addition, he stated that creating the list of reportable customers would be burdensome on the company with its limited staff.
Other Issues	Mr. Wisenteiner stated that Horn Distributing is not located in the State of Washington and does no business in Washington.
	Mr. Wisenteiner stated that there is no relationship between Horn Distributing, its customers and the City of Mercer Island.
