	WHO SHOULD FILE THIS FORM: Any person or entity making grassroots lobbying expenditures not reported by a registered lobbyist, a candidate, or a political committee exceeding \$700 in the aggregate in a one-month period or exceeding \$1,400 in the aggregate in any three-month period must register as a sponsor of a grassroots lobbying campaign. Exception: If an organization sends a notice about pending legislation to its members, or a corporation sends a similar message to its stockholders, the expenses related to these activities are not reportable as grassroots lobbying.								
	<b>FILING DEADLINE:</b> A campaign must register and file its initial grassroots lobbying report within 24 hours of the initial presentation to the public when that occurs during the period beginning 30 days before the regular legislative session through the end of that session, or during any special session.								

Any other time of the year, grassroots lobbying campaigns must register with the PDC within five days of the initial presentation to the public. Thereafter, sponsors file monthly reports on the 10th of the month covering the preceding calendar month. When the campaign is finished and the last report is being filed, check the final report box.
