Purpose: The rules make inflationary adjustments to the lobbying reporting thresholds. The rules also amend the grass roots (indirect) lobbying requirements, including clarifying the reporting of grass roots lobbying activities. The rules also make miscellaneous changes to other lobbying reporting requirements, including technical changes and other clarifications. The rules make additional inflationary adjustments for campaign finance values as a follow-up to prior rulemaking, and make miscellaneous changes to the campaign finance rules, including correcting references to reporting values that were previously adjusted for inflation.
