
State Public Disclosure





Accepting Contributions

- Separate bank account needed to accept contributions
- Candidates can be their own treasurer
- Anonymous contributions cannot exceed:
 - \$500 per calendar year, or
 - 1% of total per calendar year
 - Whichever is greater




- Governed by a written agreement between campaign and loaner
