The Xerox Corporation Political Action Committee (XPAC) is in receipt of the Washington State Attorney General's Office letter dated June 15, 2017 notifying the PAC of a citizen's action notice from Mr. Glen Morgan regarding a contribution from XPAC to Jay Inslee for Washington. XPAC is an out-of-state political committee located in Washington, D.C. and registered with the Federal Election Commission. We have checked our records and found that we reported this contribution to the Federal Election Commission (FEC) on our regularly scheduled July 20, 2016 FEC report, thereby honoring the interest of public disclosure.

Unfortunately, we cannot find a record of having filed with the Washington State Public Disclosure Commission. We have further checked our records and found that this was the only contribution that XPAC has made in connection with a Washington State election in well over a decade. This was an honest mistake on our part and we are anxious to correct the mistake. We are happy to file the missing C5 report if you deem appropriate. We will await guidance from your office.
