Subject: Complaint regarding Dennis Eros, PDC Case 23140

Dear Jimmy Hilliard:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on July 21, 2017. Your complaint alleged that Dennis Eros may have violated RCW 42.17A.555 for misuse of public facilities to support campaign of candidate Nikolich.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- On June 21, 2017, the Board of Commissioners voiced their intent to appoint Candidate Steven Nikolich to fill the vacancy to be caused by Carol Fox. No action was taken at that meeting. Candidate Nikolich was duly appointed at the August 16, 2017 meeting of the Board of Commissioners.
- To the extent that appointing Candidate Nikolich may support his election campaign, it is exempted from enforcement as "normal and regular conduct of the office or agency" per RCW 42.17A.555(3).

Based on these initial findings, staff has determined that in this instance, any benefit that may have been granted to Candidate Nikolich by voicing intent to appoint does not amount to a material violation warranting further investigation.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing enforcement action in this case.
