Subject: Complaint regarding EJ Zita, PDC Case 28122

Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on November 28, 2017. Your complaint alleged that EJ Zita may have violated RCW 42.17A.235 and RCW 42.17A.240 by failing to timely and accurately disclose contributions, expenditures, and debt; in addition to violating RCW 42.17A.555 for using public facilities for campaign purposes, and RCW 42.17A.335 for failure to include sponsor identification.

As a result of PDC staff's initial review, we found the following:

- The allegations contained in the complaint underlying PDC Case 28122 are substantially similar to a citizen action complaint that you filed with the Attorney General's Office pursuant to RCW 42.17A.765.
- On March 22, 2018, the PDC became aware that a lawsuit containing substantially similar allegations as the complaint underlying PDC Case 28122 was filed in Superior Court.
- The Superior Court now has primary jurisdiction over the substance of this complaint, and the PDC will defer to their judgment in bringing the issues to resolution.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
