

## File a Formal Complaint - Glen Morgan

To Whom it May Concern --

(Please note, this complaint is intended to replace the complaint I recently sent to your office. I had forgotten to include additional evidence of his violations in that complaint, which are included here. Please disregard the previous, incomplete complaint which I had sent to your office a few minutes ago):

It has come to my attention that Senator Sam Hunt has once again, habitually and willfully committed frequent and multiple violations of **RCW 42.17A**. Additionally, I have reason to believe that other violations of this chapter have occurred beyond what I have identified below.

### **1) Failure to file accurate, timely C3 and C4 reports. (Violation of RCW 42.17A.235)**

State rule requires that contingent contractual liabilities are reportable as debt on form C4 from the time the contract is entered into until the liability is voided, paid or otherwise satisfied. **WAC 390-16-042.**

Senator Hunt's campaign entered into a contingent contractual liability with the State of Washington when he signed the following settlement agreement (contract):

Senator Hunt failed to report the suspended portion of the penalty (\$1,367.50) as debt on schedule B of form C4, as required by state law and rule. Specifically, this was not reported as contingent contractual liability on form C4 for relevant time period: <https://web.pdc.wa.gov/rptimg/default.aspx?batchnumber=100784184>

Additionally, despite the recent lawsuit filed by the AG's office on violations of this exact nature, the following C3 and C4 reports were filed late. It is stunning, particularly considering Senator Sam Hunt's expertise in this area of the law and his recent legal troubles associated with his failure to follow the law that he would continue to violate the law in such an extensive and reckless manner.

The PDC should investigate the possibility that Senator Sam Hunt committed the above violations maliciously, which would be a class C felony per **RCW 42.17A.750 (2)(c)**. If the PDC determines that is the case, they should refer the case to the Attorney General's office for criminal prosecution immediately.
