Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on December 19, 2017. Your complaint alleged that WEA-PAC may have violated RCW 42.17A.205, 42.17A.235, 42.17A.240, .42.17A.255, 42.17A.270, .42.17A.320, 42.17A.425, and WAC 390-16-037 by failing to timely and accurately report contributions and expenditures and by failing to comply with other campaign finance requirements.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- The allegations contained in the complaint underlying PDC Case 29104 are substantially similar to a citizen action complaint, filed with the Attorney General's Office pursuant to RCW 42.17A.765.
- The PDC became aware that you filed a lawsuit in Superior Court in the name of Washington State on June 6, 2018, containing substantially similar allegations as the complaint underlying PDC Case 29104 was filed. Case 18-2-02884-34.

The Superior Court now has primary jurisdiction over the substance of this complaint, and the PDC will defer to its judgment in bringing the issues to resolution.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
