Hello Micaiah,

I left you a voice mail, but will respond here and send more information if requested. It isn't clear to me if you have actually received a copy of the emails in question.

The email on **6/29**, was an incidental statement from a constituent wishing me luck on the election, and lamenting the political majority in our city. The main conversation was related to her ongoing concerns about the use of Round-up in our community, and efforts to gain support for its ban.

Emails of **7/13, 7/17, 7/30 and 8/01**, referred to in the complaint were sent prior to Proposition 1 (change in government form from Commission to Council) being placed on the ballot. Through contention and lack of support by the other commissioners, it was determined that the citizens' desire for a choice in form of government would have to be done via citizen initiative. The emails were a sample petition to proponents of placing it on the ballot that had been approved by our city attorney, and forwarded to me through our city manager. There was also a clarification of when the petitions would need to be returned in order to place it on the ballot. I didn't promote the change using my city email, although it was a topic of discussion in our public meetings for many weeks.

After the petitions were returned and verified, and the other commissioners were bound to pass the resolution placing it on the ballot, it became part of my campaign platform and I didn't mention or promote it in any way using my city email.

The emails of **8/26 and 8/29** were communications with a reporter who was writing an article on the proposed change of government and details of the process. It was merely an invitation and acceptance to meet for an interview on private property. Details of the proposition were not discussed using email or city property.
