Dear Glen Morgan

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on March 7, 2018. Your complaint alleged the King County Democratic Central Committee may have violated RCW 42.17A.240 for failure to accurately file the Summary Full Campaign Contribution and Expenditure reports (C-4 reports) and RCW 42.17A.205 for failing to update its Political Committee Registration (C-1pc).

PDC staff reviewed your allegations to determine whether the record supports a finding of one or more violations. Based on staff's review, we found the following:

- The allegation contained in the complaint underlying PDC Case are substantially similar to a citizen action complaint, filed with the Attorney General's Office pursuant to RCW 42.17A.765.
- On July 19, the PDC became aware that a lawsuit containing substantially similar allegations as the complaint underlying PDC Case was filed in Superior Court in the name of Washington State.

The Superior Court has primary jurisdiction over the substance of this complaint, and the PDC defers to its judgment in bringing the issues to resolution.

Based on this information, the PDC finds that no further action is warranted and has dismissed this matter in accordance with RCW 42.17A.755(1).
