Subject: Complaint regarding Teresa Purcell, PDC Case 32997

Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on February 6, 2018. Your complaint alleged that Teresa Purcell may have violated RCW 42.17A.255 and RCW 42.17A.405 for exceeding contribution limits and for failure to file independent expenditure reports.

PDC staff reviewed your allegations, and as a result of staff’s initial review, we found the following:

- The allegations contained in the complaint underlying PDC Case 32997 are substantially similar to a citizen action complaint, filed with the Attorney General's Office pursuant to RCW 42.17A.765.
- On May 31, 2018, the PDC became aware that a lawsuit containing substantially similar allegations as the complaint underlying PDC Case 32997 was amended to include the additional allegations in the complaint filed in Superior Court in the name of Washington State.
- The Superior Court now has primary jurisdiction over the substance of this complaint; the PDC will defer to their judgment in bringing the issues to resolution.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
