Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on March 27, 2018. Your complaint alleged that De-Escalate Washington I-940 may have violated RCW 42.17A.205 for failure to amend Political Committee Registration (C-1pc report) to reflect changing position from supporting to opposing I-940.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- RCW 42.17A.205(2) requires political committees to disclose candidates or ballot propositions they support or oppose, but remains silent on support or opposition to acts of legislation.
- No evidence has been presented to support the allegation that De-Escalate Washington I-940 began opposing I-940 at any time.

Based on these initial findings, staff has determined that in this instance, no evidence supports a finding of an actual material violation warranting further investigation.

Based on this information, the PDC has dismissed this matter in accordance with RCW 42.17A.755(1), and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
