Dar Mr. Blackhorn:

Below is the LM PAC response to the complaint filed by Glen Morgan on April 10, 2018.

1. Failure to file accurate, timely C3 and C4 reports, failure to timely deposit contributions.

All reports have been filed accurately and all deposits have been timely filed. The LM PAC treasurer has consistently used ORCA exclusively to file all PDC reports. See the attached spreadsheet with regard to specific C3 and C4 complaints.

2. Failure to report last minute contributions.

There is no evidence provided to support this allegation. All contributions have been timely reported.

3. Failure to list committee officers, timely file update C-1/C-1PC.

There is no evidence provided to support this allegation. All officers have consistently been listed on the C-1's filed. All current officers are on the currently filed C-1 and this C-1 was timely filed.

4. Illegal unauthorized expenditure of funds, by an individual not listed as an officer on form C-1/C1-pc.

There is no evidence provided to support this allegation and I can find nothing in our records that would even suggest such a mistaken allegation.

5. Failure to preserve books of account, bills, receipts and all other financial records of the campaign or political committee for not less than five calendar years following the year during which the transaction occurred.

There is no evidence provided to support this allegation. All books, bills, receipts and other financial records have been kept as required.

6. Illegal depositing of campaign funds into bank account by person other than the treasurer or deputy treasurer.

There is no evidence provided to support this allegation. All deposits have been made by individuals authorized to do so.

7. Failure to include sponsor ID.

There is no evidence provided to support this allegation. While the LM PAC has made contributions to candidate campaigns, it has not engaged in political advertising or independent expenditures.

8. Failure to timely file form C6 reporting independent expenditure.

There is no evidence provided to support this allegation. The LM PAC has not engaged in independent expenditure campaigns.
