Comment: I saw your 2017 complaint against Gina McCabe (now Mosbrucker) on the PDC website. I am currently an opponent who noted a discrepancy on her April schedule B. Her only expenditure was \$500 to an unlicensed consulting service. Since it was unlicensed, I was unable to research the nature of the services. I contacted the PDC, who in turn contacted McCabe's campaign. The response: It was a "mistake," it was not meant to be reported on the form at all. This was May 14-18th. On May 22, the consultant filed for a city business license to begin legal operations. What I suspect happened is the pledge or money was rescinded to cover up the fact that this was an unlicensed business. I have all the documentation, including the un-amended schedule B before it was erased. The consulting firm, interestingly, is a religious group, run by a former or current, I can't tell, grant officer at Yakima Valley Community Foundation. To my knowledge YVCB does not receive federal CDBG so the employee is not precluded from campaigning in her spare time.

Just a friendly patriotic reminder from the Alliance for Justice's website. 501(c)(3)'s, including churches and religious organizations, may not favor political candidates. "Individuals who work for or serve as board members for a 501(c)(3) may, run, but it is important for the 501(c)(3) associated with the candidate to avoid supporting or opposing the candidacy, as well as avoid giving the appearance of supporting or opposing the candidacy." According to AFJ, candidates may not use their email lists, office supplies, meeting space, and so on. AFJ also notes that employees of nonprofit organizations that receive federal grants, in particular, Community Service Block Grants, may be subject to provisions of the Hatch Act – a federal law that restricts the political activity of federal government employees. These employees may not be candidates for public office in a partisan election and their political activities are limited to their free time. The law's purposes is to ensure that federal
