Subject: Complaint regarding Derek Young, PDC Case 36738

Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on June 11, 2018. Your complaint alleged that Derek Young may have violated RCW 42.17A.235 and RCW 42.17A.240 for failure to accurately disclose in-kind contributions.

PDC staff reviewed your allegations, and as a result of staff’s initial review, we found the following:

- Derek Young did not accurately report a \$642.92 in-kind contribution received in December, 2017 from the Washington State Democratic Committee.
- Mr. Young acknowledged that he neglected to report the in-kind contribution from the state party as the result of an oversight.
- PDC Staff also confirmed that Derek Young may have experienced technical difficulties in ORCA when amending his C-4 reports.
- The applicable C-4 reports are now amended and Derek Young has confirmed that the mistake has been corrected.

PDC staff is reminding Derek Young about the importance of the timely and accurate disclosure of all contribution and expenditure activities, including the filing fee, and the timely filings of all future PDC reports.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
