Description

The Jefferson County Republican Central Committee offered an inappropriate item for auction on 4/24/18. Jon Cooke, Chair of the Party and a custodian for Jefferson County, donated “clock tower tour” and “clock tour” as auction items valued at \$20 each. Four bidders paid a combined \$46 to the Jefferson County Republicans Central Committee for five tours (Steve Crosby, \$10; Shari Morrison, \$8; Robert Burns, \$8; Mark Fuller, \$20 for two tours).

The only local clock tower is at the historic Jefferson County Courthouse. It offers panoramic views of Port Townsend, our bay, Jefferson County, and both the Cascade and Olympic Mountains. Jon Cooke, the contributor, is employed as a custodian in the county, and has worked in the courthouse recently. He may have been working there at the time of this auction.

People can make arrangements through to county to take tours at no cost. Inquiries about tours are referred to the Prosecuting Attorney’s office, as access is through his inner office.

What impact does the alleged violation(s) have on the public?

Public confidence in the electoral process is damaged when a political party uses county facilities for fundraising purposes.

A political party that does not adhere to this RCW gains an unfair advantage in fundraising.
