

File a Formal Complaint - Glen Morgan

To Whom it May Concern --

I am writing to inform you that Andrew Biviano has committed multiple violations of RCW 42.17A in his campaign for Spokane County Commission.

1) Biviano failed to file his C1 (and likely his F1) within the two week period after becoming a candidate, as required by law. He became a candidate no later than 5/5/2016, when he purchased the domain name www.andrewbiviano.com. The paperwork should have been filed on or by 5/19/2016, however he failed to do this.

2) Biviano failed to include "paid for by" statement at the bottom of his webpage andrewbiviano.com.

3) Biviano failed to report the expenditure or in-kind contribution of the purchase of his website domain.

It appears that a "Mike Lee" was the person who actually made the in-kind contribution of the website domain to the campaign.

4) Biviano failed to accurately report debt.

On his 9/1/2016 C4 covering the time period of 7/26 to 8/31, Biviano lists an expenditure on 7/29 for "Slim Jim" printing. It is very likely that this expenditure was actually made well before 7/26, as an order to replace dwindling slim jims for their doorbelling operation during the primary campaign.

The PDC must make an inquiry as to when the order for the "Slim Jims" was actually placed. If it was placed before 7/26, then the C4 for the time period of 7/12 to 7/25 must be corrected to reflect the debt.

5) Biviano failed to report the expenditure or in-kind contribution of the professional "introduction" video that can be found on the landing page of his website.

6) Biviano failed to include both written and spoken sponsor ID and partisan identification in his "introduction" video that can be found on the the landing page of his website.

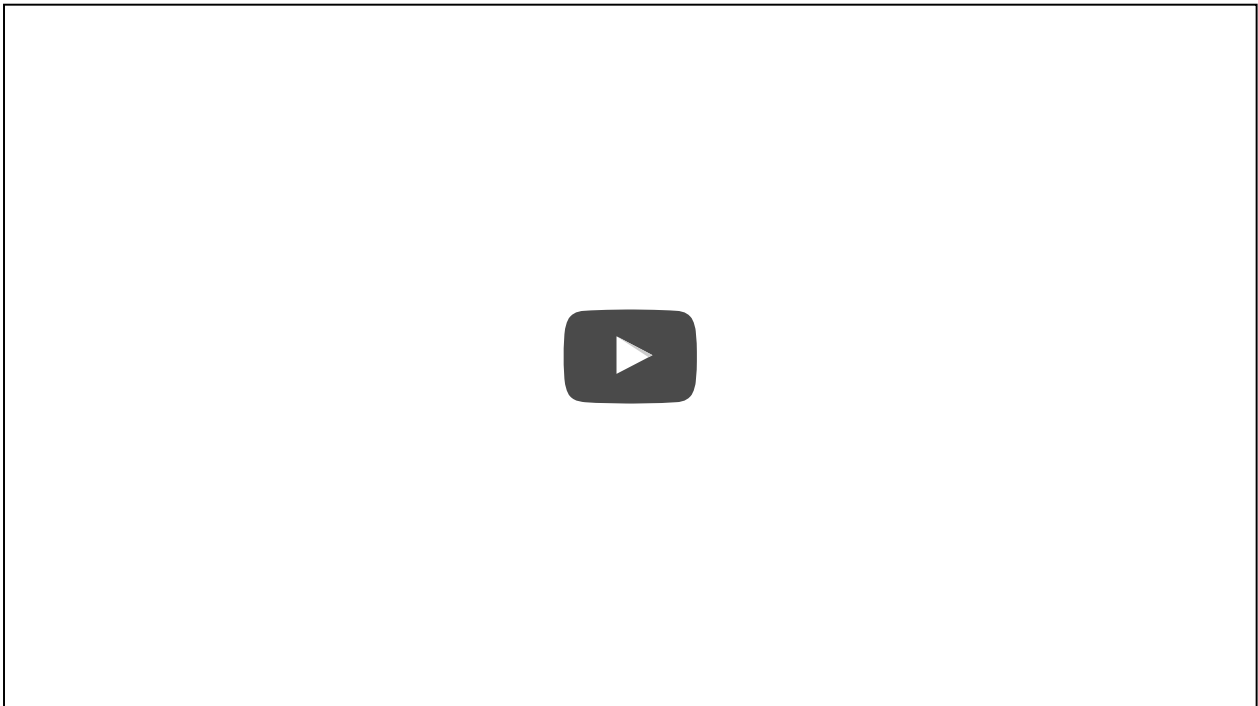
