<b>Explanation of Rule(s)</b>	<p><b>Personal residence - Real property.</b> Regarding reporting the information otherwise required by RCW <a href="#">42.17A.710</a> (1)(h) through (k):</p> <p>(i) Under WAC <a href="#">390-24-200</a>, the filer shall list the street address of each parcel, the assessor's parcel number, the abbreviated legal description appearing on property tax statements, or the complete legal description. Each property description shall be followed by the name of the county in which the property is located.</p> <p>(ii) No modification will be necessary if the filer describes the real property using one of the alternatives in WAC <a href="#">390-24-200</a>, plus the name of the county.</p> <p>(iii) A modification will be required if the filer seeks some other means to describe reportable real property including the personal residence of the filer. The commission may consider a modification, for example, when the filer or his or her immediate family member has received a threat, has a no contact order, or presents a similar personal safety concern.</p> <p>A prospective modification to allow nondisclosure of a residential address may be granted if the applicant or an immediate family member has received a threat, been issued a no contact order or presents a similar personal safety concern.</p>

	<p>information, including street address, parcel number, or legal description, on his Personal Financial Affairs Statement covering calendar year 2018.</p> <ul style="list-style-type: none"><li>• Judge Clary stated that he hears and decides criminal and civil cases where he makes decisions that affect people who may retaliate or threaten his or his family's safety. He recently spent several weeks hearing a series of three homicide cases including vehicular homicide, second degree murder and first-degree murder.</li><li>• Judge Clary stated that he regularly presides over cases involving drug dealers and felons possessing fire arms. The families and friends of defendants attend the sentences and project ill feelings for the sentences.</li><li>• In his original request for a modification, Judge Clary stated that prior to his appointment to the Spokane Superior Court, he had served as an attorney and had not listed his home address in order to keep him and his family safe.</li></ul>
<b>Other Issues</b>	<p>Judge Clary disclosed creditor information, payment terms, security given and mortgage amounts for his personal residence.</p> <p>Judge Clary has agreed to recuse himself if a matter came before him involving a conflict of interest between his personal residence and Spokane County Superior Court.</p> <p>Judge Clary has reviewed his initial reporting modification request and any subsequent renewal requests and has certified that there are no changes to the facts related to his request.</p>
