Background	Mr. MacIntyre has disclosed the identity of clients for whom he did legal work for during the previous 12 months prior to his retirement from Perkins Coie, LLP.
Reason(s) for Modification (as stated by filer)	<ul style="list-style-type: none"> • Mr. MacIntyre is requesting a reporting modification that would exempt him from disclosing the business customers that paid \$10,000 or more during the previous 12 months, to Perkins Coie, LLP, a law firm. • Mr. MacIntyre was a partner with Perkins Coie, LLP until July 31, 2012 and retained no ownership interest in the firm after retirement. He stated that at the time of his retirement Perkins Coie had approximately 850 attorneys operating in 18 U.S. offices and one office in Asia. In addition, he stated that the firm employed approximately 1,200 to 1,500 other employees. Mr. MacIntyre was advised by the firm's Professional Standards Counsel that there are currently 50,000 clients in the firm's client data base, located in all 50 states along with a dozen or more foreign countries. • Mr. MacIntyre stated that based on the reporting period for disclosure as a candidate and his retirement from Perkins Coie, his reporting modification request would apply to a three-month period of time. In addition, he stated that prior to his retirement he worked on a reduced schedule of approximately 50% or less than his normal work level. Mr. MacIntyre stated that based on the nature of the firm's business he can estimate that hundreds of the firm's clients are likely to have paid \$10,000 or more to Perkins Coie. • Mr. MacIntyre stated that he does not have access to any Perkins Coie business records and that prior to his retirement he had limited access to the specific information concerning the firm's clients.

Other Issues	Mr. MacIntyre stated that he has never provided legal services for the Port of Kingston nor has Perkins Coie ever represented the Port of Kingston or received any payments.
Staff Recommendations	Approval pending receipt of publicly available client list for Perkins Coie, LLP.
