<b>Reason(s) for Modification (as stated by filer)</b>	<ul style="list-style-type: none"> <li>• Ms. Daudon is requesting a reporting modification that would exempt her from disclosing the business customers who paid \$12,000 or more during 2014 to Cascadia Consulting Group Inc., for whom her husband, Marc Daudon, is President /Principal and has a 45% ownership interest.</li> <li>• Ms. Daudon is also requesting a retroactive reporting modification that would exempt her from disclosing the business customers who paid \$12,000 or more during 2013 to Cascadia Consulting Group Inc.</li> <li>• Ms. Daudon stated that Cascadia Consulting is an environmental and sustainability consulting firm serving public and private clients with offices in Seattle, Washington and San Jose, California. The firm has 45 employees.</li> <li>• Ms. Daudon stated that she does not have access to the firm's client list and there are approximately 12 reportable business customers of the firm.</li> <li>• Ms. Daudon stated that some former business clients are listed on the firm's website. She stated that the website also lists the firm's public/governmental clients.</li> <li>• Ms. Daudon stated that disclosing the firm's business customers would cause a competitive hardship because the firm's competitors would become aware of the names of Cascadia's clients. She further stated that the client list is proprietary and that it would be disadvantageous to have all of their clients listed in one place and to have clients in the same sector knowing whom they serve. She said the firm has non-disclosure agreements with some business clients.</li> </ul>
