<b>Explanation of Rule(s)</b>	<p><b>Income and ownership interests.</b> An applicant may be exempted from reporting the information otherwise required by RCW 42.17A.710 (1)(f) and (g), if: (i) Public disclosure would violate any legally recognized confidential relationship; (ii) The information does not relate to a business entity which would be subject to the regulatory authority of the office sought or held by the applicant in whole or in part; (iii) Such reporting would present a manifestly unreasonable hardship to the applicant including but not limited to adversely affecting the competitive position of an entity in which the applicant had an interest of ten percent or more as described in RCW 42.17A.120; and (iv) The interest in question would present no actual or potential conflict with the performance of the duties of the office sought or held.</p>

<b>Reason(s) for Modification (as stated by filer)</b>	<ul style="list-style-type: none"> <li>• Mr. Jones states that he is requesting a reporting modification to exempt him from disclosing business customers paying \$12,000 or more to Lake Union Dry Dock Co Lake Union Drydock Co during 2019 reported on his annual F-1 filed on April 14, 2020.</li> <li>• Mr. Jones states that he is requesting a retroactive reporting modification to exempt him from disclosing business customers paying \$12,000 or more to Lake Union Dry Dock Co Lake Union Drydock Co on his Candidate F-1 covering May 2018 through May 2019, filed on April 20, 2020.</li> <li>• Mr. Jones states that he has a 13.4% ownership in Lake Union Drydock Co. which makes \$15-20 million in annual sales.</li> <li>• Mr. Jones states that disclosing the non-governmental customers of Lake Union Drydock Co. would create a competitive disadvantage to this small business shipyard.</li> <li>• Mr. Jones states that he has “provided publicly available information but reserved non-public information as it protects the company’s customer list” including customers listed on government and municipality sites.</li> <li>• Mr. Jones states that he does have access to Lake Union Drydock Co.’s customer list, and they do have the ability to identify those paying more than \$12,000 or more during the reporting period, however all of their business customers would meet that threshold during the reporting period.</li> <li>• Mr. Jones states that Lake Union Drydock Co. is not in the Clyde Hill jurisdiction and there is no connection between the two.</li> </ul>
<b>Other Issues</b>	<ul style="list-style-type: none"> <li>• Mr. Jones states that he will recuse himself from any potential conflicts that may arise between his interests as a City Council Member for the City of Clyde Hill and Lake Union Drydock Co.</li> <li>• Mr. Jones held a City Council Member position in a city with less than 5,000 registered voters in previous years and ran for City Council Member of City of Clyde Hill for the first time in 2019. He states he was unaware of the filing requirements until he took office and was told he needed to file annually.</li> </ul>
