<b>Reason(s) for Modification (as stated by filer)</b>	<ul style="list-style-type: none"> <li>• Judge Lutes is requesting a reporting modification that would exempt him from disclosing his personal residential address information on his F-1 report for 2013.</li> <li>• Judge Lutes is also requesting a modification that would retroactively exempt him from disclosing real estate, including street address, parcel number, or legal description, for property previously listed on F-1 and F-1A reports for calendar years 2003 to 2012.</li> <li>• Judge Lutes, after attending a judicial seminar, has been advised to protect his personal residential information.</li> <li>• Judge Lutes stated that recently there was an incidence of violence in another Asotin County court room which further demonstrates the need for personal safety.</li> <li>• Judge Lutes stated that he presides over a wide variety of different cases which has caused verbal fighting between long time residents of Asotin County and those from outside the area.</li> </ul>
