Reason(s) for Modification (as stated by filer)	<ul style="list-style-type: none"> • Ms. Morgan is requesting a reporting modification that would exempt her from disclosing the business and governmental customers who paid \$12,000 or more during 2014 to Morpac Industries, Inc. (MORPAC), of which she is a partner with a 17.6% ownership interest. • Ms. Morgan is also requesting a retroactive reporting modification that would exempt her from disclosing the business and governmental customers who paid \$12,000 or more during calendar year 2013 and from May 2012 to December 2012 to MORPAC. • Ms. Morgan stated that MORPAC is a custom manufacturer of specialized equipment for the electric utility and electric valve actuator markets with offices in Washington, Arizona and Canada. • Ms. Morgan stated that MORPAC has 75 employees and annual sales in excess of 1.7 million. • Ms. Morgan stated that MORPAC is an approved government supplier whose customers supply the US Navy. Several of the customers are foreign governments. MORPAC also supplies specialized equipment to various public utilities across North America. • Ms. Morgan stated that there are approximately 2,000 reportable customers and that she does not have access to the customer list. In addition, she stated that creating a list of the reportable customers would be burdensome due to the sheer volume.
