<b>Explanation of Rule(s)</b>	<p><b>Personal residence - Real property.</b> Regarding reporting the information otherwise required by RCW <a href="#">42.17A.710</a> (1)(h) through (k):</p> <p>(i) Under WAC <a href="#">390-24-200</a>, the filer must list the street address of each parcel, the assessor's parcel number, the abbreviated legal description appearing on property tax statements, or the complete legal description. Each property description must be followed by the name of the county in which the property is located.</p> <p>(ii) No modification will be necessary if the filer describes the real property using one of the alternatives in WAC <a href="#">390-24-200</a>, plus the name of the county. Judges, prosecutors, or sheriffs may describe a personal residence in the alternative manner provided under RCW <a href="#">42.17A.710</a>(2), and WAC <a href="#">390-24-200</a> without a modification.</p> <p>(iii) A modification will be required if the filer seeks some other means to describe reportable real property including the personal residence of the filer. The commission may consider and grant such a modification to amend the description of a residential address to the extent necessary to protect the applicant or an immediate family member who has received a threat, has obtained a no contact order, or has presented a similar personal safety concern.</p>

<b>Reason(s) for Modification (as stated by filer)</b>	<ul style="list-style-type: none"><li>• Mr. Rosenbaum is requesting a new and retroactive reporting modification that would exempt him from disclosing his residential address on her Personal Financial Affairs Statements (F-1 report) covering calendar years 2019, 2020, and the F-1 filed as a candidate in 2019 covering the previous twelve months, due to safety concerns.</li><li>• Mr. Rosenbaum stated that his request is being made due to specific threats made by a neo-Nazi against his wife and family resulting in a conviction on five separate federal charges.</li><li>• Mr. Rosenbaum stated that the group making the threats is known for their ability to use open-source information, such as home addresses, to learn about potential targets.</li></ul>
<b>Other Issues</b>	<p>Mr. Rosenbaum has agreed to recuse himself if a matter came before him involving a conflict of interest between his personal financial information and his duties as an elected official.</p> <p>PDC staff have informed Mr. Rosenbaum of the residential address alternatives set forth in <a href="#">WAC 390-24-200</a>.</p> <p>Mr. Rosenbaum's records would be exempt from public disclosure if the Commission finds in accordance with <a href="#">RCW 42.17A.120</a> and <a href="#">WAC 390-28-080</a> that disclosure of such information would present a personal risk to a reasonable person.</p>
