An applicant may be exempted from reporting the information otherwise required by RCW 42.17A.710 (1)(f) and (g), if:</p> <p>(i) Public disclosure would violate any legally recognized confidential relationship;</p> <p>(ii) The information does not relate to a business entity which would be subject to the regulatory authority of the office sought or held by the applicant in whole or in part;</p> <p>(iii) Such reporting would present a manifestly unreasonable hardship to the applicant including but not limited to adversely affecting the competitive position of an entity in which the applicant had an interest of ten percent or more as described in RCW 42.17A.120; and</p> <p>(iv) The interest in question would present no actual or potential conflict with the performance of the duties of the office sought or held.</p>

Reason(s) for Modification (as stated by filer)	<ul style="list-style-type: none"> Mr. Reid is requesting a renewal of the reporting modification that would exempt him from disclosing the business customers that paid \$12,000 or more during 2017 to Alpine Evergreen Co., Inc. (Alpine).

	<ul style="list-style-type: none">• Mr. Reid is also requesting a renewal of the reporting modification that would exempt him from disclosing Washington real estate parcels in which Alpine held a direct financial interest of \$24,000 or more during 2017.• Mr. Reid stated that Alpine is a family-owned timber company, owned by 16 family members with a 9 member board. The company employs a full-time manager, a part-time field supervisor, and a part-time bookkeeper. Mr. Reid holds a 24% ownership interest in the company and serves as Chairman of the Board.• Mr. Reid stated that Alpine's reportable customers include approximately 9 sawmills and export companies. They also receive royalties from a gravel mine.• Mr. Reid stated that Alpine's board of directors believes that disclosing the company's customer list would adversely affect the competitive position of the company by informing their competitors of who they sell their timber to and would also inform them of the percent and quantity of each grade of wood the company is growing.• Mr. Reid stated that disclosing the parcels of real estate held by the company would be too lengthy and cumbersome to compile given the limited staff resources. He stated that the company owns approximately 5,800 acres in 5 counties in Washington. He said he would be agreeable to disclosing the total number of acres held in each county in Washington. He stated that Alpine does not own land within the boundaries of the Port of Waterman.• Mr. Reid stated that Alpine's business is not related in any way to the Port of Waterman.
Other Issues	<p>Mr. Reid disclosed that Alpine has one governmental client –U.S. Department of Agriculture.</p> <p>Mr. Reid has resigned his position as an elected Port Commissioner, effective April 17, 2018.</p>
